3. COURSE DESCRIPTIONS:

Catalog Description:

Study theoretical and practical application of nail tips and wraps, artificial nails, nail disorders and disease, skin disorders and disease, chemical texture services, communication for success, preparing for licensure, working on the job, and salon business. Continued practice in skill building while applying and executing theoretical and practical discipline competencies, as prescribed by the California Board of Barbering and Cosmetology.
