**VIII. New Business, Discussion, and Information Items**

**a. Pete Guinosso: The Art of Sequencing – Open Heart Yoga**

Open Heart Yoga (OHY) gave a presentation for funding requests for the Art of Sequencing. Motion to recommend approving funding request to the Senate by Chess; seconded by Active Minds. Members of ICC inquired if the event would be held on campus. OHY said that yes, it would be. Members asked if there would be an admissions fee. OHY responded that yes, there would be an admissions fee, but that it would be discounted for students. OHY indicated that the proposal does not cover the complete cost of Mr. Guinosso's fee. OHY could not provide the full amount that Mr. Guinosso is charging for the workshop.

By a vote of 12 in favor, 1 opposed, and 9 abstaining, the motion to recommend approval of the funding for the OHY workshop carries.

**b. Pete Guinosso: The Art of Seeing Energy – Open Heart Yoga**

Open Heart Yoga gave a presentation for funding requests for The Art of Seeing Energy. Motion to recommend approving funding request to the Senate by Chess; seconded by Makerspace. Members asked if there would be an admissions fee. OHY responded that yes, there would be an admissions fee, but that it would be discounted for students. OHY indicated that the proposal does not cover the complete cost of Mr. Guinosso's fee. OHY could not provide the full amount that Mr. Guinosso is charging for the workshop.

Due to the lack of information, the Chess Club motioned to table the item until next week to allow OHY to gather more information; seconded by AGS. Hearing no objections, the motion carried.

**c. Trip to S.F. Asian Art Museum for the Yoga: The Art of Transformation Exhibit – Open Heart Yoga**

Open Heart Yoga gave a presentation for funding requests for The Art of Transformation Exhibit at the Asian Art Museum. Motion to recommend approving funding request to the Senate by Chess; seconded by Phi Theta Kappa. Motion to amend proposal to increase funding to \$200 grand total to \$500 for entrance fee by Chess and Seconded by Active minds. Friendly amendment to back to \$100 grand total is now \$500.

By a vote of 13 in favor, 8 opposed, and 0 abstaining, the motion to recommend approval of the funding for the OHY workshop carries.

**d. CSM Spring Dance Concert – Performance Dance Ensemble**

Performance Dance Ensemble gave funding requests for their Spring Dance Concert. Motion to recommend approving funding request to the Senate by Fashion club; seconded by Filipino Student Association.

By a vote of 18 in favor, 0 opposed, and 2 abstaining, the motion to recommend approval of the funding for the PDE Spring Dance Concert carries.

**e. Nursing Graduation/Pinning Ceremony – Nursing Student Association**

Nursing Student Association gave a funding proposal for graduation ceremony. Motion to recommend approving funding request to the Senate by Alpha Gamma Sigma; seconded by Anatomy.

By a vote of 19 in favor, 0 opposed, and 1 abstaining, the motion to recommend approval of the funding for the NSA Graduation Ceremony carries.
