REPORTS

President Roe welcomed members of the Senate and guests from the Board of Trustees to the meeting. Mr. Roe reminded the Senate that the Public Safety Open Forums would take place on campus on Wednesday, Sept. 14. The open forum exclusively for students is scheduled for 3:30 PM on Wednesday. President Roe also informed the group that the "Fall in Love with a Major" fair would take place on Wednesday in the Bayview Dining Room. Finally, Mr. Roe reported that last Friday he attended the Institutional Planning Committee meeting where the group discussed possible changes to the IPC mission statement, the accreditation mid-term report, and possible revisions to the College Index.

Vice President Stein had no report.

Finance Director Kaffl welcomed everyone to the meeting and commented that it was nice to see so many students interested in getting involved.

Vice Chair McReynolds reported that he attended the Faculty Academic Senate Governing Council meeting. The group had a presentation on the Year One program, which is ramping up and looking for more students. The first two

introductory Inter Club Council meetings have concluded so clubs are going to start submitting proposals. The dates for the Club Fair have also been decided: The event will be held Wednesday, Sept. 21 and Thursday, Sept. 22.

Commissioner of Publicity Chin reported that she attended the College Assessment Committee meeting. The committee is developing new methods for assessing general education requirements. The committee is also trying to develop methods to help faculty evaluate how well students meet course SLOs and how best to track that information via TracDat.

Secretary Darzi had no report.

Senator Gomez reported that she attended the Committee on Instruction meeting. The COI approved two online accounting classes for next semester and a sport psychology class. The committee also discussed the prerequisite of ESL 400 for some courses and the possible addition of a Harmony II class.

Senator Topete Eng Goon reported that she had attended the Student Services Council meeting. The council discussed recent changes to FERPA that require schools to release student information to parents/guardians if they claim a student on their taxes as a dependent. This release of information does not require any consent from the student. The council also discussed how to make it easier for transgender students to use their preferred names on campus, how to make the financial aid appeal process faster, and how to promote the new dental services that will be available to the campus community on the first and third Thursday of each month. Ms. Topete Eng Goon also attended the Fall Semester Registration Debrief meeting. One of the primary topics to come from that meeting was finding ways to increase the awareness of counseling services on campus.

Senator Wong announced that the Cultural Awareness Board would hold its first meeting on Wednesday, Sept. 21 at 1:10 PM in Building 10, Room 401.

Senator Relos reported that she had attended the Sustainability Committee meeting. The committee is discussing ways to integrate sustainability into the college's curriculum and increasing campus involvement in issues of sustainability. The group wants to launch the "Sustainability Success Network," which would be an interdisciplinary program to have students come together to do work around sustainability issues. Finally, the committee wants to hold more events on campus. In October, the Cesar Chavez Community Garden near Building 1 will be replanted. In addition, plans for the Earth Day event in April are already underway.

Senator Mat Kamal reported that he had attended the Distance Education and Educational Technology Committee meeting. The group discussed the College and District transition from WebACCESS to Canvas for online course management.

Student Life and Leadership Manager Schaefer had no report.

Student Life and Leadership Assistant Hamadeh distributed fliers and asked that the Senate help promote the campus forums on Public Safety. Mr. Hamadeh reminded the group that the focus of these forums is not solely on the issue of arming Public Safety Officers. Although the topic is likely to come up, the forums are part of an overall assessment of the District's Public Safety program. Mr. Hamadeh also announced that the campus Respect Forum will take place on Friday, Sept. 23 at 1 PM in the College Heights Conference Room (Building 10, Room 468). The forum will highlight the various diversity and equity programs that are taking place at the College. Finally, Mr. Hamadeh announced that several SafeZone trainings have been scheduled for the month of October. The trainings are open to the entire campus community.

NEW ACTION, DISCUSSION, AND INFORMATION ITEMS

REVISION TO THE ASCSM BYLAWS REGARDING THE COMMISSIONER OF PUBLICITY

Due to the importance of the role of the Commissioner of Publicity, President Roe recommended revising the ASCSM Bylaws to make the Commissioner a member of the Executive Cabinet, not just an *ex-officio* member. This change requires striking the words, "an ex-officio, non-voting" from Article IV, Section 2.1(c) of the Bylaws and adding "a."

Motion to approve the revision to the ASCSM Bylaws regarding the Commissioner of Publicity by Senator Awwad; second by Senator Chettipally. With a vote of 16 in favor, 0 opposed, and 0 abstaining, the motion carries.

ASCSM GOALS FOR 2016/17

After extensive discussion at a prior meeting, the final wording of the ASCSM Goals for 2016/17 were presented to the Senate. The goals are:

NOT ANYMORE VIDEOS PROMOTION

After asking the Senate to view the videos, Mr. Schaefer and Mr. Hamadeh requested feedback and suggestions. Members of the Senate suggested asking faculty and staff to promote the videos; utilize the clubs and organizations as a way to get the word out about the videos; explore ways to make the videos more accessible such as banner ads in WebSMART; integrate the videos into Counseling classes, orientations, and Welcome Day; stress to faculty the importance of the information being conveyed in the videos and not have it framed as just another requirement; coordinate an event among the three A.S. boards that focuses on sexual assault and violence. Mr. Schaefer suggested that the Senate place an item on the next agenda to discuss hosting such an event.

COLLEGE OF SAN MATEO JAZZ FESTIVAL PROPOSAL

The 20th Annual College of San Mateo Jazz Festival is a not for profit event hosted by the CSM music department. This event is designed as an educational tool for high school jazz programs in San Mateo County and the greater Bay Area. There will be eighteen high school jazz groups performing throughout the day beginning at 8:00 AM and ending at approximately 6:00 PM. Each group will receive a workshop and recorded critiques of their performances by noted jazz educators. In addition, there will be clinicians giving workshops in the areas of woodwind performance, brass performance, and rhythm section performance. The event will be held in the College of San Mateo Theatre on Friday, November 18, 2016.

There will be a free noon concert featuring the College of San Mateo Monday Evening Jazz Ensemble with guest artist Jeff Jarvis. Mr. Jaris is a professional composer and trumpet artist and is the director of the CSU Long Beach Jazz program. There will be approximately 350 high school students participating in this event, and perhaps an additional 200 parents, educators, CSM students, and community members will be in the audience throughout the day. This event is extremely beneficial for our music program and the College of San Mateo, as it brings the 350 students to our campus to experience our program first hand. Our instrumental music program has tripled in size the past five years, primarily though the exposure provided by our jazz festival.

The festival also provides an opportunity for students in our Music 100, 202, 250, and 275 courses to fulfill their concert attendance requirements free of charge, and offers them the convenience of staying on campus to complete these projects. There are approximately 350 CSM students enrolled in these classes.

Each participating group pays an entry fee of \$275 to help offset the majority of the festival expenses. I would like to request funding in the amount of \$2,000 to cover the cost of our adjudicators for this year's event. Our adjudicators are: Dr. Gregory Yasinitsky from Washington State University, Dr. Steve Roach from Sacramento State University, Dr. Aaron Lington from San Jose State University, Dr. Patrick Langham from the University of the Pacific, and Dann Zinn from CSU East Bay.

This year's CSM Jazz Festival marks the twentieth year of this outstanding event. It is one of the more popular festivals from the standpoint of the participating directors who return each year to participate. Your consideration of this request is greatly appreciated.
