CALL TO ORDER

The meeting was called to order at 2:19 p.m.

APPROVAL OF THE AGENDA

Motion to approve the agenda as presented by Senator Topete Eng Goon; seconded by Senator Liu. Hearing no objections, the motion carried.

APPROVAL OF THE MINUTES OF PRIOR MEETING(S)

Motion to approve the minutes of the Monday, September 18, 2017, meeting Senator Topete Eng Goon; seconded by Senator Bathai. Hearing no objections, the motion carried.

ANNOUNCEMENTS AND HEARING OF THE PUBLIC

None.

REPORTS

President Riley hoped that everyone had a great weekend, and noted that the weather this week was pleasant; Mr. Riley thanked those who had worked on preparing for the hurricane relief fundraiser. He stated that the Senate should be proud of all that they were doing so far.

Vice President Relos wished Commissioner of Publicity Gomez Torres a happy belated birthday. She then recounted a meeting she and Mr. Riley had attended with student government representatives from Cañada College and Skyline College; Ms. Relos remarked that they had all hoped to develop more collaboration between each college in the future, and that any suggestions to achieve this were welcome. Vice President Relos reminded the Senate that filming for the DACA support video would commence soon, and that, if anyone had feedback on the draft of ASCSM's official statement, to let her know as soon as possible. Included in the agenda was a filming schedule for the DACA support video; members of the Senate were expected to show up at their allotted times to recite their parts of the statement.

Finance Director Helsel reported that ASCSM had allocated \$35,000 to a multitude of events, clubs, and programs for the campus; he also indicated that \$6,000 was charged for attendance at the CCCSAA conference, \$83 to supply ASCSM's

hurricane relief fundraiser, and \$3,082 for production of Unity t-shirts. Mr. Helsel noted that, so far, ASCSM had spent a total of \$6,411.

Vice Chair Paing announced that Club Fair would take place on Wednesday, September 27th, and Thursday, September 28th, from 10:00 a.m. to 1:00 p.m. on both days. Tables for ASCSM, the three ASCSM boards, and the hurricane relief fundraiser would all need volunteers throughout the event.

Secretary Chavez stated that he would create a signup sheet online for the ASCSM table at Club Fair, and encouraged fellow members of the Senate to continue to help out with the ASCSM hurricane relief fundraiser.

Senator Xu recalled her attendance at the recent International Education Committee meeting; she reported that events coordinated by the committee were open to all students. Such events include the weekly World Chat, the World Village—which would take place on November 15th in Building 10 and entail dance, food, and art from different countries—as well as the World Gala in April. Ms. Xu pointed out that there were several study abroad and international internship programs for students who wanted to immerse themselves in other cultures to enhance their academic experience; she also remarked that changes would be made to the international student orientation. Senator Xu briefed the Senate on Photography Club's upcoming photography exhibition that would take place throughout the campus.

Senator Topete Eng Goon reminded the Senate that the ASCSM hurricane relief fundraiser was still going on, and encouraged members to seek donations even if they were not currently tabling; she told the Senate that, if they had any questions, they could talk to herself, Senator Bathai, or Secretary Chavez. Ms. Topete Eng Goon reiterated Vice President Relos's point, asserting that everyone needed to show up to their scheduled times for filming ASCSM's statement in support of DACA. While filming, members would be asked to present what they stand for.

Senator Bathai told the Senate that Programming Board had just had their first meeting, and that plans for a Halloween/fall festival were currently beginning to roll; the event will take place on Tuesday, October 31st, and Wednesday, November 1st. She stated that any help from Senate members and potential board members would be appreciated.

Senator Soni declared that Alpha Gamma Sigma would conduct fundraising to help host a fall leadership conference at Cañada College; he asked Senators to see if they could help out during their fundraiser.

Senator Meneses notified the Senate that EOPS Club was planning a fundraiser to support those affected by the earthquake in Mexico, and that they were still researching organizations to donate funds to.

Student Life and Leadership Assistant Hamadeh told the Senate that he might not be on campus on Wednesday for accreditation training. Advisor Hamadeh encouraged members to attend the retirement party for Dr. Henry Villareal, former Dean of Enrollment Services, on Tuesday at 2:00 p.m. in Building 10. Mr. Hamadeh asked members to get clubs to register for the Club Fair as soon as possible, and remarked that, all clubs needed to get their presidents and treasurers to attend the mandatory club officer orientation. He also underscored the importance of punctuality, insisting that members show up to the Senate meetings on time.

LEGISLATIVE BILLS

Senator Topete Eng Goon declared that Advocacy Board would soon have bills for the Senate to discuss; she motivated fellow Senate members to let her know if there were any bills they wanted to bring to Advocacy Board.

FUNDING FOR MEDICAL SCHOLARS' FAMILY SCIENCE DAY EVENT

Chris from CSM's Medical Scholars Club proposed \$170 in funds to have the club participate in Family Science Day on Saturday, September 30th. The club was planning on hosting a phantom limb experiment and a human brain experiment, as well as giving out organ-shaped candy. \$100 would fund the human brain experiment, and the remaining \$70 would go towards the candy. This event would take place in the Anatomy/Physiology Lab in Building 36.

Motion to approve \$170 to fund the Medical Scholars' Family Science Day event by Senator Topete Eng Goon; seconded by Senator Meneses.

By a vote of 16 in favor, 0 opposed, and 0 abstaining, the motion passed.

FUNDING FOR BRANDED ASCSM CANOPIES

The Senate discussed funding canopies branded with the ASCSM logo to utilize during events; this would help promote ASCSM's presence on campus. Advisor Hamadeh noted that the canopies were a bit pricey because they included both the canopies, as well as the frames to hold them up; he told the Senate that they were planning to purchase steel frames along with the canopies because they would be durable. In the future, only the frames would need to be replaced. A total of \$5,000 was proposed to buy four canopies/frames.

Motion to approve \$5,000 to purchase four canopies and their frames by Senator Bathai; seconded by Senator Meneses.

By a vote of 16 in favor, 0 opposed, and 0 abstaining, the motion passed.

FUNDING FOR ASCSM APPAREL

Student Life and Leadership Assistant Hamadeh lodged \$5,000 to fund the purchase of more ASCSM t-shirts and polo shirts; he indicated that shirts would be made for both the Senate and for the three ASCSM boards. Mr. Hamadeh also conveyed that the Senate would be able to decide what kind of winter apparel they wished to purchase; several options included windbreakers, hoodies/sweatshirts, and quarter zip-up sweaters. The topic would be further discussed at a future Executive Cabinet meeting.

Motion to approve \$5,000 to fund the purchase of ASCSM apparel by Senator Wang; seconded by Senator Briones.

By a vote of 16 in favor, 0 opposed, and 0 abstaining, the motion carried.

APPROVAL OF ACTION STEPS FOR ASCSM GOALS 2017-18

A list of the action steps to fulfill ASCSM's goals for this academic year was presented to the Senate. Once adopted, the action steps would be further discussed by the Executive Cabinet.

Student Trustee Olguin, Jr. encouraged the Senate to include connections with the district's Board of Trustees in their list of action steps for communication. This would open ASCSM up to more district-wide initiatives, as well as opportunities to collaborate with Cañada College and Skyline College. Mr. Olguin, Jr. also encouraged the Senate to get ASCSM more involved in local events to increase its presence in the community.

RESOLUTION

In Support of Codifying DACA into Federal Law

WHEREAS, On September 5, 2017, the Trump Administration ordered an end to the program known as Deferred Action for Childhood Arrivals, or DACA, and the Administration has urged Congress to identify a replacement within six months before the Administration phases out DACA's protections. The outcome will determine the legal status and ultimate fate of approximately 800,000 immigrants, known as "Dreamers", who were brought into the United States as children and who are eligible – under the existing DACA program - to apply for temporary residency in the United States; and

WHEREAS, in an act of faith and trust in America's promise of opportunity and the historical legal principle of not punishing children for the actions of their parents and/or guardians, "Dreamers" gave their names, addresses and telephone numbers to the United States Government to participate in the DACA program; and

WHEREAS, the callous decision by the Trump Administration to end the Deferred Action on Childhood Arrivals (DACA) program is antithetical to American values and abandons the promise made to over 800,000 individuals pursuing the American Dream.

WHEREAS, the average DACA recipient immigrated to the United States when they were six years old and has spent the majority of their lives living in the U.S.;

WHEREAS, the DACA Program has offered the opportunity for hundreds of thousands of Americans to reach their educational goals regardless of their immigration status;

WHEREAS, this shortsighted political calculation of ending DACA inhibits the aspirations of 222,795 Californians including the 72,000 estimated to be California community college students; and

WHEREAS, our vision for California's community colleges is to provide access to a quality public higher education for all Californians, and as the largest public system of higher education in the U.S., we take great pride in being the pathway to opportunity for Californians of all backgrounds.

WHEREAS, a study of DACA recipients by the University of California, San Diego, found that the incomes of those participating in the program increased by 45%;

WHEREAS, a recent analysis by the CATO Institute found that the U.S. economy could be reduced by \$215 billion, and the federal government would lose \$60 billion in tax revenues with the elimination of DACA;

WHEREAS, DACA recipients are ineligible for federally funded financial aid programs such as subsidized loans, grants, scholarships or work study, subsidies provided by the Affordable Care Act, Medicaid, food stamps or cash assistance despite paying income, sales, and other taxes;

WHEREAS, seventy percent of DACA recipients are in school and 92% of them identify DACA as permitting them to pursue educational opportunities they previously unavailable;

WHEREAS, to qualify for DACA eligible applicants must not have committed a felony or significant misdemeanor, have been brought into the country under the age of 16, have lived continuously in the United States since 2007 and have to be either currently in school, have graduated from high school or have been honorably discharged from the U.S. armed forces;

WHEREAS, President Trump has put the educational goals and career aspirations of hundreds of thousands of Californians on hold and their future and America's economy at risk; and

WHEREAS, we remain steadfast in our commitment to educational opportunity and will stand with "Dreamers" to protect quality public community colleges for all Californians;

BE IT RESOLVED, that the Associated Students of College of San Mateo hereby urges the Congress of the United States, and our State and local leaders - in keeping with the highest and best traditions of our pluralistic constitutional democracy - to acknowledge and accept the moral imperative of relieving these victims of circumstance from the fear of deportation, and to provide our nation's "Dreamers" with continued relief from deportation, and a path to permanent citizenship; and

BE IT FURTHER RESOLVED, that the Associated Students of College of San Mateo urges San Mateo County's Congressional members to uphold California values, and to fill the leadership void created by President Trump's decision, and to codify protections contained within the Deferred Action for Childhood Arrivals Program that will permit thousands of California "Dreamers" to achieve their highest potential.

ASCSM Goals for 2017-18

PARTICIPATION

Increase and encourage participation by Senate members in Senate and board events.

- The Executive Cabinet shall hold members accountable for the number of hours they contribute to ASCSM events.
- Members shall be required to reach a set number of volunteer hours at ASCSM events during the semester.
- Distribute sign-ups to the boards so that board members may support ASCSM events.
- The Executive Cabinet shall develop and implement a tracking/reward program.

COMMUNICATION

Find innovative ways to advertise the Senate, clubs, and ASCSM activities.

- Members shall promote the role of ASCSM and ASCSM events/activities to classes.
- Members shall be more active in sharing information on ASCSM events/activities via social media.
- Develop and send out monthly emails from Student Life on various ASCSM and club events.
- Increase the use of ASCSM branding to heighten interest in ASCSM's purpose as well as its activities.
- Continue to broaden advertisement through social media, signage, and on-campus displays.
- Increase outreach and conduct research, including but not limited to surveys, to create enhanced dialogue regarding student concerns. Seek new and innovative opportunities to reach out to all students to gain a better grasp on the issues students may be facing.
- Develop a stronger relationship with the CSM learning communities.

Improve communication between the boards.

- Hold a mixer with members of the ASCSM Senate and the boards to increase community and collaboration.
- Board chairs will be responsible for apprising their respective boards on what other ASCSM groups are doing.
- Enhance communication to the boards regarding ASCSM related events and activities.

SENATE GOALS

Plan more creative and inclusive programming.

- Invite more guest speakers to campus.
- Develop more events to support underrepresented groups on campus.
- Expand support for local establishments (restaurants, vendors, etc.).
