#### New Business, Discussion, and Information Items

#### a. Overview of the Ralph M. Brown Act

President Hamadeh explained The Ralph M. Brown Act and main points of focus. Agendas must be sent out at least 72 hours before the meeting. Agenda items can be removed but not added after the 72 hours. All sessions of Classified Senate are open to the public. Closed sessions are only for personnel or legal issues. Brown Act language should be posted so all classified employees have an understanding of policies.

#### b. Overview of Parliamentary Procedure/Robert's Rules of Order

President Hamadeh opened the conversation about parliamentary procedure and Robert's Rules of Order. He mentioned that both are considered 'best practice'. All votes of the Classified Senate are public – there will be no secret ballots and all documentation must be made available to the public. Robert's Rules of Order is a book of rules for meetings and committees that is intended to help the majority get work done, while the minority is still heard.

#### c. Classified Senate Bylaws

President Hamadeh asked for volunteers to help develop the Bylaws. Volunteers: Vice President Dave McLain, Secretary Melina Boyd, Senator Mary Vogt and Autumn Newman, Classified Employee.

#### d. Delineation of Roles between Classified Senate and CSEA

President Hamadeh gave a handout of the Comparison of Roles for De Anza College. In order to avoid issues between The Union (CSEA) and Classified Senate, the goals for each must be understood. Shared Governance is a policy for decision making, while some committees are created to collect information. The College President has the final say in anything not related to curriculum. Classified Senate cannot deal with issues regarding hours, wages, and conditions of employment. CSEA will remain the official body for classified staff.

Classified Senate members understand that there is no need for makeup time for Senate meetings. Please speak to President Hamadeh if there is any pushback.

#### e. Proposed District Code of Ethics

President Hamadeh handed out the SMCCCD Code of Ethics with the intention of updating the language. Several issues with semantics arose and the group would like for it to include more cohesive and aspirational language. President Hamadeh will take the discussion regarding changes to email as well as work with the Classified Senates from Skyline and Cañada in regards to a District wide Code of Ethics.

# **Bylaws Article xx – Appointments**

#### Section 1 Vacancies on the Classified Senate

Except for as provided by the Constitution, should a vacancy occur on the Classified Senate, the President may, with the advice and consent of the Senate, appoint a classified employee to fill the vacancy.

- 1.1 The appointment shall be effective immediately upon approval by the Senate and shall be valid until the end of the original term of office.
- 1.2 Approval of the appointment shall require a simple majority (50 percent plus 1) vote of the Senate.

# Section 2 Hiring Committees

The appointment of classified employees to hiring committees shall be a joint effort between the Classified Senate, CSEA Chapter 33, and the District Office.

- 2.1 Hiring managers shall forward a list of recommended appointments to the District Office of Human Resources.
- 2.2 Human Resources shall forward the list of recommended appointments to the CSEA Chapter 33 President and the 2nd Vice President for College of San Mateo.
- 2.3 The 2nd Vice President for College of San Mateo shall forward the recommended appointments to the Classified Senate President who shall review and provide feedback.
- 2.4 The CSEA President shall have final approval over all classified employee appointments to hiring committees.
- 2.5 The Classified Senate President shall report all hiring committee appointments at the Senate's next regularly scheduled meeting.

# Section 3 Participatory Governance Committees

The appointment of classified employees to participatory governance committees shall be a joint effort between the Classified Senate and CSEA Chapter 33.

- 3.1 Requests for appointments to participatory governance committees shall be made to the Classified Senate President.
- 3.2 The Classified Senate President shall inform the Classified Senate and classified employees of the positions available.
- 3.3 The Classified Senate President, in consultation with the Classified Senate, shall make recommendations for participatory governance appointments to the CSEA Chapter 33 President.
- 3.4 The CSEA President shall have final approval over all classified employee appointments to participatory governance committees.
- 3.5 The Classified Senate President shall report all participatory governance committee appointments at the Senate's next regularly scheduled meeting.

# **DELINEATION OF DUTIES/RESPONSIBILITIES STATEMENT**

# California School Employees Association Chapter 33 and College of San Mateo Classified Senate

#### STATEMENT OF PURPOSE

The purpose of this document is to clarify the different roles that the California School Employee Association Chapter 33 (CSEA 33) and the College of San Mateo (CSM) Classified Senate fulfill in representing the interests and concerns of classified employees. While each has a distinct charter with differing objectives, there are areas where the groups' interests and responsibilities may overlap. Pursuing the objectives of one organization within the framework of the other can be redundant or even counterproductive, thus diluting the overall effectiveness of the organizations in serving classified employees interests. By clearly understanding each organization's primary responsibilities and, we ensure that classified employees have input into the participatory governance process while at the same time are assured that classified bargaining rights are protected.

This document is an understanding between CSEA Chapter 33 and the CSM Classified Senate of the roles and responsibilities herein.

# COLLEGE OF SAN MATEO CLASSIFIED SENATE

The role of the Classified Senate is to participate effectively in the formation of District and College policy and procedures and to promote the interests of all classified employees. The Classified Senate expresses the view of classified employees (classified, classified supervisory, professional, classified exempt, academic classified exempt supervisory, confidential) in the participatory governance process, excluding all areas of Collective Bargaining.

The Classified Senate is organized to:

- Fully engage in the participatory governance structure.
- Provide a body representing the needs, concerns, and viewpoints of all classified staff.
- Recruit, from its constituency, representatives to serve on governance and College committees. Articulate the professionalism of the classified staff so that it is properly recognized and valued by faculty, administration, and the Board of Trustees.
- Manage classified staff professional development.
- Promote and represent the interests of the classified staff in the development and formulation of
  policy and practice related, but not limited, to the following:
  - o in-service education
  - o facilities and services
  - o finance and budget
  - o staffing needs

- Formulate and promote cooperative communication with other College and District organizations such as:
  - Classified bargaining unit (CSEA 33)
  - o Academic Senate
  - Associated Student Organization (SGA)
  - All participatory governance groups
- Participate in the selection of supervisory and administrative staff.

It shall be the responsibilities of the Classified Senate Officers and Senators to:

- Consider and take official positions on policy and budget recommendations, excluding matters
  pertaining to collective bargaining.
- Make recommendations and take action on behalf of the classified staff with respect to any and all issues regarding District and College governance.
- Request, obtain and convey to the classified staff in a timely manner, information and/or recommendations on policies and procedures made by the College administration and/or participatory governance system so as to allow effective consideration of these issues.
- Refer all queries, requests, and/or concerns covered by collective bargaining to the Bargaining Units, with strict adherence to the details and dictates of the Bargaining Units' Contracts.

# **CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION CHAPTER 33**

CSEA 33 is the exclusive bargaining agent for all basic unit classified employees in the San Mateo County Community College District. CSEA 33 negotiates and represents classified staff in contractual issues such as:

- Wages, including salary schedule and placement, promotions, seniority, layoff and reemployment rights, initial classification and reclassification.
- Hours of employment.
- Health and welfare benefits, including holidays and vacations.
- Leaves, transfers and reassignment policies.
- Safety conditions of employment, including district-initiated disability leaves.
- Procedures used for the evaluation of employees.
- Organizational security CSEA 767 has sole and exclusive right to have membership dues and service fees deducted by the District for employees in the bargaining unit.
- Procedures for processing grievances and disciplinary actions.
- Selection of employees to serve as representatives for CSEA 767 in participatory governance groups and in other District and College committees that request or require bargaining unit representation.

# JOINT RESPONSIBILITIES

It is the joint responsibility of the Classified Senate and CSEA 33 to ensure that classified staff has meaningful input into the decision-making processes of the District.

It is the joint responsibility of the Classified Senate and CSEA 33 to work cooperatively to further the perspectives and professionalism of classified staff as to ensure a sound institution of higher education and to support student success. The Classified Senate and CSEA 3 have a joint responsibility to avoid the development of divisive or discordant positions and/or goals, and to communicate with each other in a clear and timely manner on any issues that may affect classified staff.

The Classified Senate and CSEA 33 have a shared responsibility in the following areas, and will work cooperatively to ensure that classified employee interests are represented in:

- Selection of Administrative staff
- Staff professional development and in-service education
- Facilities and services
- Recognition awards
- Budget and Finance
- Relations and communication among the various interest groups

To ensure that classified representation is consistently speaking with a united voice it is understood that all parties must approve any public position regarding classified employees, unless the matter relates to a collective bargaining issue in which case CSEA 33 will speak for all its bargaining unit members.

# **TERMINATION OF STATEMENT**

This Delineation of Duties/Responsibility Statement may be changed or terminated by any party by giving the other two parties thirty (30) day notice of its intent to request change or termination. The parties agree to use those thirty (30) days to meet and attempt to resolve any concerns that led to the request.
