Chair, Teresa Morris called the meeting to order at 2:18 p.m.

Motion was moved, seconded and carried unanimously (MSCU) to approve the Agenda with a slight reordering, moving the PLSC AA-T proposal and the course deactivations to the beginning of the agenda.

Motion was moved, seconded and carried to approve the Minutes of May 10, 2012 with one abstention.

Motion was MSCU to approve the Minutes of September 13, 2012.

Motion was MSCU to accept the following permanent course: Business/Technology

ADMJ 771 PC 832 Arrest and Control Training (3.00 - 9.50)

(Modified Course Proposal, changes in Repeatability, Student Learning Outcomes) Accepted with the correction to SLO #4 of splitting it into two SLOs; #4 Recognize techniques of handcuffing and #5 Demonstrate proper handcuffing techniques.

Proposal for Political Science AA-T Degree

Discussion took place regarding the notation on the degree proposal, (Note: PLSC 200, which is no longer offered, will be substituted for PLSC 210). Lee Miller, the faculty submitter, wanted a statement in

writing guaranteeing the substitution. The committee felt that there was no need for such a statement on the degree requirements since there is a process in existence that allows for course substitutions. Historically, other programs that have had similar situations did not include notations. A suggestion was made to add an asterisk to PLSC 210 and move the note to the bottom of the major requirements. Refer to the (attached) revised draft.

Additionally discussion took place regarding PLSC 310 being listed as 2-3 units when it is no longer offered as a 2 unit course. Again, when courses have gone through similar changes, the old unit value was not listed on the degree requirements. It was noted that the state does review the units to make sure they are listed accurately, so this could cause a delay in approving the degree at the state level.

An additional modification was proposed and accepted to update the major requirement units from 18 semester units to a minimum of 18-19 semester units. This would account for students taking the 4 unit Math 200 course versus the other 3 unit courses listed under List A.

After the two modifications were made, the committee took a vote and the Political Science AA-T Degree was approved with a vote of 7 in favor and 3 abstentions. COI Chair, Teresa, invited Lee Miller to include any additional documentation to the minutes if desired.
