Open agenda item:

Repeatability

VPI Susan Estes informed the committee about the new repeatability regulations. Currently, the regulations are to be in effective by fall 2013.

Per state regulations, all courses will have repeatability removed. The process at CSM will be as follows: a list of repeatable courses will be distributed to the deans at their next Instructional Dean's meeting on November 12, 2012. They will then share the information with their faculty so everyone will be aware of the changes.

A memo will be generated and submitted to COI to officially remove repeatability. The Instruction Office Administrative Analyst will revise course information both in Banner and in CurricUNET effective fall 2013.

The new repeatability regulations do allow for three exceptions to the repeatability rule:

- Repeatable types of courses necessary to major requirements of CSU or UC
- Intercollegiate Athletics (including related conditioning courses)
- Intercollegiate academic or vocational competition

As in past practice, Title 5 will continue to allow students to repeat courses for grade alleviation. In addition, Marsha Ramezane, Dean of Counseling will be creating a form for students to petition to repeat a course based on approved conditions such as extenuating circumstances and legally mandated courses.

Also, students with a disability are allowed to repeat a special sourse any number of times if it is determined that such repetition is required for that person as a disability-related accommodation, as in the case of adaptive physical education courses.

Kinesiology, Dance, Art, Music and Drama will be organized into families for the purpose of leveling courses. The various levels of the courses will be grouped into families where a maximum of four courses within a family can be taken one time.

The State Chancellor's office has made it clear that colleges should not have too many families or the state will make the regulations more stringent.

Since new courses will be created (renumbered) to form families, any equivalent courses will be coded in banner to ensure there are no additional repeats.

GE Handbook subcommittee

Teresa Morris, COI chair asked for volunteers to work on the GE Handbook subcommittee. The goal is to have a draft available for committee review in March 2013. Martin Bednarek, Chris Smith and Ken Brown agreed to serve on the subcommittee with Teresa Morris. Teresa also mentioned that past COI chair, Laura Demsetz expressed an interest in helping the subcommittee.
