## GE Handbook concerning CSM's general education pattern - discussion

The chair provided an overview of the revisions proposed to the GE Handbook. Attached is the draft with revisions in blue font. There was discussion regarding several topics such as:

- possibly renumbering the GE areas (since health science was removed as a requirement effective fall 2010). The handbook will be left as is for now.
- what constitutes a major revision that triggers a new review for adherence to previously approved GE area and if the policy should be removed
- the redistribution of courses for the Language and Rationality areas as described in Title 5
- having the flexibility of allowing only one SLO to meet the particular GE area. Marsha suggested
  having a more detailed introductory paragraph stating what is required followed by the supporting

- SLOs. Continued discussion needed about usefulness or meaningfulness of including SLOs versus using only a descriptive paragraph.
- concern about assessing SLOs. Could they be removed for one year to test out the handbook, however, there would be no objective mechanism to determine applicability.

There was no resolution at the conclusion of the meeting. The chair asked committee members to review the draft again and regroup with feedback about what does and does not work. The handbook should be completed by October 2013.

The first meeting in the fall will include continued GE Handbook discussion. There may be a possible flex day meeting for subcommittee members to work on GE handbook.
