Curriculum Handbook

Teresa displayed the draft curriculum handbook and specifically discussed the sections that still need to be written:

Local Practices and Standards

Standards for learning outcomes

Clarification of differences between SLOs and Instructional objectives

Instructional Methods versus Evaluation Methods

Distance education expectations

Expectations for recommended preparation justification statements/narratives

There was discussion around the need for prerequisites and/or recommended preparations, ensuring the correct level course is selected and whether or not the advisory should be "eligibility" or "completion of". There was also concern expressed about prerequisites potentially discouraging some students from taking a course. Yet others felt if students were properly counseled early on, they could plan ahead by taking the appropriate foundational courses. Jeremy Ball referenced that colleges in Florida require students to complete a college level English course prior to taking transfer college level courses.

The objective will be to include all the pertinent information in the handbook so faculty will be better prepared to determine if an advisory or prerequisite is necessary and how to go about selecting the appropriate course.

A side discussion also took place regarding distance education. Apparently, the Virtual Campus is wanting a common course management system. They are trying to standardize a course management system throughout the state so students will have the same software management system to facilitate taking online courses. Kimberly Escamilla was concerned about how this might impact choices for our local course management system. Chris Smith heard information at a recent curriculum institute meeting agreed that while the hope is to have a standardize management system, this is something that will not happen anytime soon.
