The committee discussed the differences between Student Learning Outcomes and Specific Instructional Objectives. Several committee members expressed their interpretation of the differences. Ken Brown stated the committee options were to simply use the same SLOs as objectives, expand on the SLOs, or make them different from the SLOs. If different from the SLOs, the objectives could emphasize the rigorous manner of the course, i.e. for statistics the emphasis would be to analyze data.

A suggestion was made to remove the subheading, "Upon successful completion of this course, a student will be able to:" under Specific Instructional Objectives from the course outline. This will may help ease confusion between the objectives and the SLOs. Some feel the SLOs pertain to students, whereas the objects relate to the course.

The committee drafted an outline of the potential differences between SLOs and Objectives and ideas on what to include in the handbook. Additional discussion will take place at the next COI meeting in April.
