The 16 hour lab component was taken out of the CIS courses to comply with State Chancellor's requirements.

The State Chancellor's Office issued a memo to standardize hours. We have to follow the formula provided. Course units and hours should be within the ranges per the sample calculation tables. In the past, some CTE courses had integrated training with a range of hours covering both lecture and lab but now the hours have to be clearly defined as either lecture or lab. The standardization of hours impacts courses like Art, Music, CIS, DGME, Fire, and Police Academy.

There is detailed information in the Program and Course Approval Handbook (PCAH). It is being updated; the Chair will send a link when the handbook has been updated. She will also check into the definition of homework hours.

- **New Program**

Basic Police Academy – Certificate of Achievement - **approved**
Approved with a language change in the description to “Regular Police Officer”. This certificate is based on AJPS 107 which has 22 units. There was a discussion on including cultural diversity in the program outcomes. It was explained that the outcomes are legislated by the state. The Police Academy has 42 learning domains. Cultural Diversity/Discrimination is one of the domains and it is legislatively mandated; if a student misses hours, they have to make it up or they don't pass the academy.

Open Agenda

- CSM General Education AA/AS Degree Requirements – GE Pattern

The Chair presented a copy of the CSM GE pattern. The Committee on Instruction can make modifications in the areas. Skyline and Cañada have modified their patterns and are following the CSU GE pattern. There are pros and cons to doing this. One area to consider is the Scientific Inquiry area. At CSM we have this as Area E5a Natural Science but there is a difference in the lab requirement. Skyline and Cañada require 4 units in the Scientific Inquiry area including a lab; this is similar to the CSU GE requirements. A question was raised if adding the science lab requirement at CSM would be an obstacle for students not planning to transfer or who are in certain CTE paths. The students may have lab experience but not necessarily in the Natural Sciences.

We would like to streamline the transfer process for students and have them complete their degrees smoothly. Some options and questions committee members asked were:

1. Can we have flexible options or mix and match our local pattern with the CSU-IGETC pattern?
2. Could an option include the following?
 - Use the CSU GE pattern if a student doesn't finish the CSM degree requirements at the end of the semester but meets the CSU requirements.
 - Student finishes the local GE pattern and completes the major requirements for approved AD-Ts that CSM doesn't offer.
 - Student is not currently following a transfer path but might at some later time want to transfer.

When counselors meet with students, different options are explored depending on the students' plans. Mary Valenti and Martin Bednarek will bring discussions to their department meeting. We would like to get a better idea of what needs to be changed in the GE pattern to make it friendlier to students.

The Chair noted that GE SLOs intertwine with and affect course SLOs. Revisions of GE SLOs will drive changes in course SLOs. There could be a creative thinking outcome in the future. Madeleine Murphy, SLO Coordinator, will be invited to come to a COI meeting.

The general plan is to fix minor issues for now. There are larger philosophical issues to be addressed.

The Chair will send an email to COI members to look at GE areas to see if they fit; the areas will be assigned instead of setting up a sub-committee.

The discussion will be tabled and brought back to the committee. We need more data:

3. Data on what students need, e.g., how many more units/credits are missing to get the associate's degree? How many hours does an average student have?
 4. Data from PRIE, DegreeWorks, Program Review
 5. Intertwining between GE goals and course goals.
