Discussion on this memo is postponed to the May meeting. The Chair hopes to send out the list of pros and cons prior to the division meetings. She encouraged everyone to present information to their departments for discussion. It should be emphasized that this is a conversation; this is not decided. Details on the differences in requirements, and the impact of the proposed changes would be helpful to divisions. Some of the areas in which the CSU GE and IGETC patterns differ from the CSM GE pattern include the requirements for science lab, math, and competency.

The Registrar, Niruba Srinivasan, shared some information from a meeting she recently attended that included discussions on common assessments. The catalog contains language on satisfying the Math competency requirement for the Associate in Arts/Science degrees through SMCCD math placement testing. Students who place into a Math higher than Math 120 don't need to take a Math class; competency is satisfied by the placement test results. With common assessments, we will be placing students based on their high school classes. Niruba inquired about approving these for competency – these are not college courses. Is it acceptable to have a competency requirement that is satisfied by something other than a college experience? Under multiple measures, the student will not take a Math placement test at SMCCD; high school transcripts are reviewed. We may need language to affirm math competency in some cases. English competency is not affected.

Niruba asked the group to keep this information in mind as we go through the process. Larger conversations are needed; there are other impacts.

- Quorum  
The definition of quorum is 50% plus 1. Divisions are supposed to have 2 representatives each but some have only one. The Chair will request a revision to the Academic Senate bylaws to set the quorum for COI based on the actual number of assigned representatives, following the 50% plus 1 rule.
