The Fire Technology program prepares students to meet the high standards required to pursue a career in the fire service as a firefighter, or a member of related fire protection services.

Through the expertise of our faculty, and exposure to professional fire service personnel, students can expect to be trained in the latest theories and techniques of fire technology, fire fighting skills and emergency medical training.

A variety of pre-service courses are offered every semester during the day and in the evenings. Taking these courses help in many ways by allowing the student to gain an overview of the profession to determine if this is truly a career path they want to follow, by learning the theories they will need as a foundation for the Academy, and by working towards a Certificate of Completion or an A.S. Degree in Fire Technology.

## Firefighter I and EMT I: Basic

Successful completion of these two courses provides students with the minimum training requirements needed to be hired as a firefighter. Both of these courses are certified by the California State Fire Marshal’s Office.

The Firefighter I Academy meets on Monday and Wednesday evenings (1800 – 2200) and Saturdays (0800 – 1800) for the entire semester. There is a pre-requisite of six (6) units of Fire Technology coursework, with a C or better. Three units must be from FIRE 715 (or equivalent). EMT training is not a pre-requisite and cannot be used towards the pre-requisite.

The EMT class meets twice a week (1400 – 1900) for the entire semester. Students are required to hold at least a “B” average (80%), or better, throughout the course in order to be eligible for the National Registry Examination.

To meet the prerequisite for this class, students are must to hold current certification in either:

- American Heart Association: BLS for the Health Care Provider  
or
- American Red Cross: CPR/AED for the Professional Rescuer

## Firefighter Internship

San Mateo County Fire Cadets can receive credit for their time as a cadet for up to three semesters, when registered in FIRE 810 – Firefighter Internship. Eligible cadets will be notified by the supervising Captain at their agency.

Typically, the Fall Semester begins in August, with registration beginning in May, and the Spring Semester begins in January, with registration beginning in November.

The printed Schedule of Classes arrives on campus about one month before registration starts, and contains a listing of courses being offered for the semester, as well as student services contact information, fees and the Final Examination schedule. All students are encouraged to obtain a class schedule.

A searchable class schedule is posted on the CSM website, but does not contain any course descriptions or pre-requisite information. The printed schedule (class-listings only) and the current Academic Catalog can also be viewed online using Adobe Acrobat Reader.
