College of San Mateo Institutional Planning Committee Summary Report 2018 – 2019

During the 2018-2019 academic year, IPC focused on several initiatives related to the College's planning processes, transparency, and program improvement. The biggest of these was the drafting of the Institutional Self Evaluation Report (ISER) in preparation for the College's upcoming accreditation visit in Fall 2019, but also included: a major update to the Educational Master Plan (EMP) and the "5 in 5" Strategic Priorities; oversight and review of the first biennial Program Review cycle; finalizing the College's Planning Manual and updating committee membership, structure, and term limits; and reviewing and providing input into initiatives and plans such as Guided Pathways, the Student Equity Plan, the Distance Education Plan, and the Technology Plan.

In order to enhance transparency around the College's decision-making processes, IPC finalized the College's Planning Manual, including planning calendars and matrices outlining how all major decisions and recommendations are made. In addition, the membership of institutional committees were reviewed, reworked where necessary, and reconstituted with clearer missions and term limits. In order to demystify the College's budget process, IPC re-established the Finance Subcommittee. This committee, comprised of members of each campus constituency, is charged with ensuring "that the College maintains fiscal stability and that financial resources are allocated in accordance with the College's Mission, Vision, Strategic Priorities, Educational Master Plan goals, Program Review, and other plans."

Recognizing that the College needs to take steps to address some of the challenges that our students face, the work of the Textbook Task Force continued. In addition, IPC established a Transportation Task Force to explore what the College can do to help address transit issues to and from the campus.
