General Instructions

Application for Community College+ Scholarship 2015

The **Burlingame Rotary Club Scholarship** recognizes promising students who are, or will be, attending a 2-year community college. Subject to the judgment of the Rotary Scholarship Committee, Rotary wishes to award one or more scholarships, in amounts typically ranging from \$250 to \$1,000, to be determined by the Committee.

Eligible Applicants: Any graduate of **Burlingame High School** who is enrolled *full time* in a **community college (12 units or more)**. (Children of Burlingame Rotary Club members are not eligible for this scholarship.)

Selection criteria:

- ***academic accomplishments (minimum 3.0 GPA)***
- ***a commitment to the community***
- ***the ability to grow and to succeed in school and beyond***
- ***Financial need***

Rotary awards are given for that unique combination of these criteria and where we believe that our funds can truly make a difference.

Please note— Scholarships may or may not be awarded; and any scholarships which are awarded will be dependent solely on the determination of the Rotary Scholarship Committee, and will include our review of your chosen school's financial package.

Please submit the following with this Application:

- ✓ **Community College unofficial transcript (plus high school transcript if possible).**
- ✓ **Your personal statement** – an essay describing your experiences, achievements and plans for the future (maximum 2 pages, double spaced.)
- ✓ **FAFSA or Dream Act Student Aid Report (SAR).** (We may request additional verification of income.)
- ✓ **Digital photo** of yourself (mailto: rotaryscholarship@jumpstartadvisors.com)
- ✓ **Photo release form** (included in this application.)
