

## **Rotary Club of San Mateo: Four-year Scholarship Program, 2015**

For high school students intending to attend a four-year university or college program, two copies of the following must be submitted:

- Application—include cell phone number and e-mail address
- Parents' or guardians' 2014 tax returns must accompany application
- Transcript from high school
- 100-word essay describing educational goals

**For CSM students,** please submit the above, (your tax return if you are independent); CSM transcripts; and two copies of all material, not stapled.

For career and college advisors, please:

- Copy all documents one-sided only
- Do not staple packets, please use paper clips
- Submit two copies of all documents

**Deadline for submission of applications is Thursday, March 12, 2015, 12 noon to Karen Chadwick, Financial Aid Office.**

Selection for interviews will be based on financial need, acceptance at a four-year college, and other financial support (e.g., grants, other scholarships, savings).

Rotarians will review all applications and tax returns, and letters will be mailed to students regarding their status. A list of the students accepted or rejected will be mailed to advisors. Students accepted for interviews will be contacted by a Rotarian to set up an in-home interview, with a parent or guardian present, if the student is 18 or under. Final interviews with the Rotary panel will be held on April 21<sup>st</sup> and 22<sup>nd</sup> after 4 pm in the San Mateo City Hall. The Rotary Awards Luncheon will be held on May 7<sup>th</sup>.
