Seniors – Class 2016, please submit two copies:

- Application
- Your parent(s)' 2015 Federal income tax return
- Transcript
- A 100-word essay describing your educational goals.

College Advisors

- Copy all documents on one side only
- Do NOT staple each packet—paper clips, please
- Submit two copies of all documents

CSM students, please submit two copies:

- Your parent(s)' 2015 Federal income tax return or your own if you are independent (only required for four-year scholarships)
- Only your CSM transcripts
- A 100-word essay describing your educational goals
- Submit **two copies** of your application, tax return and essay, do NOT staple, paper clip each packet

Selection is based on financial need and acceptance to a four-year college.

Deadline to submit your application to your College Career and Financial Aid Advisor is Thursday, March 10, 2016

- Letters will be mailed to students regarding acceptance for an interview
- Students will be contacted by a Rotary member to arrange an in-home interview for the four-year applicants
- Final interviews will be held in April
