REPORTS

Chair Ryan Luftman said he was excited to join the ICC and looks forward to working with the group for the rest of the semester. Mr. Luftman also said that a task force will be established to help plan the upcoming Club Fair.

Vice Chair Vanshika Sharma said she is looking forward to a fun semester together.

Student Life and Leadership Assistant Fauzi Hamadeh reminded groups to sign-up to participate in the Club Fair, which is coming up on Tuesday, February 20, and Wednesday, February 21. He also reminded the group that any club presidents and treasurers who did not attend a Club Officer Workshop during the fall semester must attend a workshop this semester or their club will be suspended. Finally, Mr. Hamadeh encouraged members of ICC to consider running for the 2024-2025 ASCSM student government. There will be 16 senator positions available in addition to the president, vice president, and finance director positions.

OVERVIEW OF THE ROLE AND FUNCTION OF ICC

Mr. Hamadeh provided an overview of the role and function of the Inter Club Council, how it relates to the Student Senate, how clubs may request funding, and the requirements of the Ralph M. Brown Act and parliamentary procedure. He noted that clubs may request a maximum of \$2,500.00 per semester and no more than \$3,500.00 per academic year. There is also a one-time funding allocation of \$1,000.00 available for on-campus events. Mr. Hamadeh said that funding

proposals must be submitted no later than 4 p.m. on Thursday to be included on the following week's ICC agenda. Groups must send representatives to both the ICC meetings and the Student Senate meetings to talk about their proposals or else they will not be considered. Mr. Hamadeh pointed out that funding from ICC and the Student Senate is never guaranteed and that no expenditures should take place before final approval is granted.

FUNDING FOR GUEST SPEAKERS - COMPOSERS CLUB

The Composers Club is requesting funds to bring two guest speakers to campus to discuss composing new music. The group is also planning to have a concert of original student work later in the spring semester.

Motion to recommend approval to the Student Senate of \$400.00 from the Club Assistance/ICC account (#5031) to support the guest speakers and concert for the Composers Club by Active Minds; seconded by Operation Smile. The motion was carried with 21 voting in favor, 0 opposed, and 0 abstaining.

FUNDING FOR REGISTRATION FOR THE 2024 ACTIVE MINDS CONFERENCE – ACTIVE MINDS

The Active Minds group is requesting support to send representatives to the national Active Minds Conference in August. The requested funding will cover registration for seven students and one advisor.

Motion to recommend approval to the Student Senate of \$970.00 from the Club Assistance/ICC account (#5031) to fund registration for seven students and one advisor from the CSM Active Minds chapter to attend the national Active Minds Conference in August 2024 by Student Veterans Club; seconded by Chinese Students and Scholars Association. The motion was carried with 21 voting in favor, 0 opposed, and 0 abstaining.

TOOLS AND MATERIALS – SCENTED CANDLE CLUB

The Scented Candle Club, which is newly formed this semester, needs supplies, materials, and tools to make candles. This funding will allow the group to purchase enough supplies for the remainder of the spring semester.

Motin to recommend approval to the Student Senate of \$1,300.00 from the Club Assistance/ICC account (#5031) to support the purchase of tools and materials for the Scented Candle Club by Active Minds; seconded by CSSA. The motion was carried with 20 voting in favor, 0 opposed, and 1 abstention.

Mr. Hamadeh reminded the group that there would be no ICC meeting next week due to the Club Fair. The group's next meeting will be Tuesday, February 27.
