Resolution in Support of Utilizing Student Government Funds to Support Students in Emergency Circumstances

- Whereas, the California Community College system is the largest system of higher education in the world, serving over 2.1 million students; and
- Whereas, the California Community College system is built on the foundations of open access and supporting all students; and
- Whereas, many California Community College students were already dealing with financial insecurities, food insecurity, housing insecurity, and transportation challenges; and
- Whereas, the COVID-19 pandemic has in many ways exacerbated or worsened these challenges; and
- Whereas, many California Community College district rely on the FCMAT ASB Accounting Manual to provide guidance on how to administer Associated Students funds; and
- Whereas, the ASB Accounting Manual recommends against the direct granting of Associated Students funds to individual students as a "gift of public funds," and
- Whereas, in an emergency, Associated Students organizations should have the flexibility and opportunity to provide direct support to students in needs;
- Therefore, be it resolved, that the Associated Students of College of San Mateo do request the California State Legislature codify in the Education Code and Title V the ability for California Community College Associated Students organization to provide direct financial support to students;
- Further, be it resolved that the Associated Students of College of San Mateo do request that the California State Legislature add language to the Education Code and Title V that provides Colleges and Districts guidance on the proper expenditure of Associated Students funds.
