Chair, Teresa Morris called the meeting to order at 2:21 p.m.

Substantive Agenda

Courses listed on the substantive agenda have been reviewed for listed changes. Though courses on the substantive agenda may have changes in prerequisites and/or recommended preparation, the full committee is expected to review prerequisites and recommended preparations statements for all proposals to ensure compliance with Title 5 regulations.

New Courses

PHYS 680MC Just-In-Time Support for Physics 210 (1) – *approved; discipline assignment: Physics*

PHYS 680MD Just-In-Time Support for Physics 250 (1) – *approved; discipline assignment: Physics*

The Just-In-Time Support for Physics courses are not required and are nondegree applicable and non-transferable. There are plans to make the courses permanent.

Action on the two experimental courses had been postponed pending an answer to Ron Andrade's question about how repeatability comes into play if a student passes the support Physics course but not the required main Physics class. Since the class is a graded course, this affects repeatability. The Chair inquired why the grading system is Grade Option. The committee discussed the pros and cons of changing the grading system from Grade Option to Pass/No Pass. On one hand, there may be students who need additional credit, but on the other hand, there might be less incentive for students to put in more effort for a Pass/No Pass grade. Mike Holtzclaw suggested setting high criteria for students to pass. Nico van Dongen shared that he teaches a .5 unit class with a Letter Grade option but at the beginning of the class, he sets specific criteria for the grades and majority of the students choose the Grade option.

Martin Bednarek informed the group that even if a course is not degree applicable, the course will be part of the total units on the student's transcript. The system will calculate all the grades, not just the grades from the degree applicable courses. Counselors, Admissions & Records, or the student will eliminate the unit when calculating the units and GPA for the Associate's degree. Having a letter grade on this course affects academic standing.

The courses were approved with the request that when the courses are proposed for permanent course numbers, data should be provided on how

the course fared or how students performed in the experimental courses and what grade option they chose.

SOCI 160 Sociology of Sex and Gender (3) - *postponed*

(Proposed for E5b Social Science and E5d Career Exploration and Self-Development)

Review of this new course was postponed, pending faculty submitter's input on Madeleine Murphy's comments on the SLOs, and decision on discipline assignment/s. The SLOs match the C-ID.

Open Agenda

- Update on AB 705

The Chair presented a document showing proposed changes to Title 5 language incorporating changes that emanated from AB 705 and information from guidance memos issued by the State. There could be changes to General Education, which would impact the committee's discussions on GE. The document is currently open for comments from the public. The document covers Math and English competencies, residency requirements, and Language and Rationality areas. The document proposes that English and Composition requirements be met by English and ESL courses. Changes would affect our AA/AS Degree worksheet.

In spring 2018, the committee had started discussing narratives and SLOs for GE areas to simplify things. There had been a proposal to modify the E2 areas and make the following changes:

- E2a: English Composition (No change)
- From E2b: English, Literature, Speech Communication to E2b: Communication
- From E2c: Communication and Analytical Thinking to E2c: Analytical Thinking

Skyline and Canada are following Title 5 formats and use CSU language. CSUs and UCs prepare a guidance memo to help faculty determine what they need to do get a course into a particular GE area. We don't follow this exactly, but we could. CSM doesn't use the CSU language. We have narratives and SLOs in our curriculum handbook. Many

times, the SLOs are not useful in putting course in certain GE areas, and we had discussed paring these down.

The Chair presented the proposed changes to Area E2 Language and Rationality that had been discussed last spring. The committee discussed whether to delete the SLOs and just leave a narrative, keep some SLOs, edit SLOs, or break down a part of the narrative to create more specific SLOs. Making these changes will change the process we have been using of matching SLOs when deciding on GE designations.

Teresa will send out a copy of her PowerPoint presentation to the committee and will present the newly proposed changes to GE Area E2 at the next meeting. We will continue discussions on the GE areas.
