This course is targeted towards new students to give them an early exposure to research. The course is multidisciplinary: Physics, Engineering, Biology, Chemistry.

There was a lengthy discussion on the catalog description and this was revised to better reflect what the course is offering.

Ron Andrade asked: Currently faculty aside, will the course always have the four disciplines? It may not be necessary to have four faculty teaching this class. One option is to have two primary faculty; one to cover Physics/Engineering; another to cover Biology/Chemistry. It's also possible that a single instructor has the required background to teach the whole course right now, but we need to think about future staffing as well. The discipline assignment is not linked to the course prefix.

David Laderman asked about the relationship of this course with the Science Honors courses. There may be some overlap, but there is also potential for partnership, and the courses can complement each other.

Course Reactivation

CHIN 201 Chinese Character Writing for Beginners (3) – *approved; discipline* assignment: Foreign Languages

(Removal of corequisite; changes in units, hours, method of grading, description, SLOs, objectives, content, methods of instruction, assignments, evaluation, and texts)

This course had been deactivated a few years ago due to budget cuts. Recently, there has been renewed interest in a course on writing Chinese characters, including from business professionals who do business in China. They are interested in being able to read meeting agenda, street names, menus, etc. written in Chinese. Students also want to learn to write short notes in Chinese. No other college or university in the Bay Area is offering this course.

New Programs

CPA Exam Prep: Accounting Foundation – Certificate of Specialization (11 units) – approved

The Accounting Department revised their courses per instructions from the Chancellor's Office to reduce the certificates from 18 units to less than 16 units. This new certificate could be the first in a series, although it is not a foundational program and is not required. All Accounting certificates can be taken independently.

Music – Certificate of Achievement (27-35 units) - approved

Open Agenda

• Addition of a local Associate Degree GE Pattern Option Marsha Ramezane handed out copies of the proposal to adopt the Transfer General Education pattern as another GE pattern option for students. It supports degrees in Architecture, Photography, Chemistry, Engineering, Dance, Ethnic Studies, Nursing, Spanish, and Digital Media. Other communities offer this as option for their local GE patterns. It is useful for high-unit degrees where the transfer degrees don't work. It can also help students get multiple degrees. Chris Walker mentioned that some of our sciences don't have AS degrees. There could be an impact with reciprocity for sister schools, but Skyline and Cañada are already following the CSU pattern. The proposal was approved for acceptance. It will be effective in Fall 2019.

GE Area E2: Language and Rationality

The Chair presented some slides on the GE E2 areas that have been under discussion during the past few meetings. She offered some options on curriculum outcome language. The first two list outcomes to consider; the first implies that one outcome is enough; the second indicates that more than one outcome is required. The third is a narrative: "When placing courses in a general education area, the Curriculum Committee considers how well and whether the course content, instruction methods, and evaluation methods address the following learning outcomes." Can we use a similar method for looking at other items on the course outline?

In the curriculum and in the GE handbook, there will be information on how we do our GE designations as a committee. For curriculum committee procedure: Consider: course content, representative instructional methods, evaluation methods; ask for more details on the course outline rather than relying on implied activities. Consult the guiding notes from CSUs/UCs without losing the CSM focus. The Chair might assign this piece of the handbook to member/s.

For E2c Analytical Thinking: UCs and CSUs use the term "Critical Thinking"; it means something specific to them. Our proposed title is "Analytical Thinking" which comes from Title 5 language. We have to consider what is meant by Analytical Thinking. It has been possible for students to prove competency in quantitative thinking without taking a Math class; they can take CIS classes. Chris wanted to know the purpose of having GE areas that differ from those of CSUs and UCs. Marsha said that we would like to help students like workforce development students who do not get associates degrees, e.g. Electrical program and some DGME programs. Judith Hunt pointed out that we would not want to keep students from getting degrees because they could not complete some Math classes. We need to figure out appropriate thresholds for students.

Policy about high-impact courses being banked - postponed
