Chair, Teresa Morris called the meeting to order at 2:15 p.m. She explained the reversal in the order of substantive and consent items. Sample courses were taken from a list of similar courses. We will review their DE supplements and approval or changes will apply to the similar courses under the consent agenda.

**Student Services** 

The Chair made a couple of announcements:

- CSUs approved a new GE area F for Ethnic Studies. This will impact our curriculum process. She encouraged everyone to look into this.
- Teresa has been Curriculum Committee Chair since 2010 and this will be her last year. We will need a new Chair, for members to vote on. Interested parties may contact her; mentoring will be provided. Some experience with curriculum is required. There is release time funding for being Curriculum Chair and some of the funds in the spring can be used for the next Chair to shadow Teresa.

Teresa informed the group that one reason we are in a hurry to review and approve the DE supplements is that Division Assistants are currently working on coding the Spring 2021 classes as online as the courses get approved to be offered as distance education in Curriculum Committee. Our process impacts the work of Division Assistants. If a course is not on the Chancellor's list and will be offered in spring and does not have distance education, it needs to be proposed for DE. The Chair has a list and can send it out. A course that does not have DE cannot be offered in spring.

Judith Hunt suggested adding a checkbox specifically to ask if hybrid is an option. It is hard to figure out if people just forgot to check it or if it's intentional. It could read like: No, I don't want to offer as hybrid. The Chair thinks this is a good idea and we could implement it in the future. It would cause confusion if we add it at this time. Currently, there is no CurricUNET report to distinguish between hybrid and online classes.

Motion by Martin Bednarek to approve the agenda, seconded by Ron Andrade, all members voting "Aye".

Courses listed on the substantive agenda have been reviewed for listed changes. Though courses on the substantive agenda may have changes in prerequisites and/or recommended preparation, the full committee is expected to review prerequisites and recommended preparations statements for all proposals to ensure compliance with Title 5 regulations.

# Course Modifications

ACTG 175 Volunteer Income Tax Preparation (2.5) – *approved with the addition of hybrid option.* Motion by Martin Bednarek, seconded by Ron Andrade, all members voting "Aye".
(New DE supplement; changes in methods of instruction, assignments, and evaluation) Jeremy Ball asked about adding hybrid as an option. Initially, the Accounting faculty did not consider this option as in their

experience, students prefer fully online or fully face to face classes. In hybrid offerings, there may be enough students at the beginning of the course, but students drop out and very few are left at the end. Sometimes it's not worth having hybrid classes.

Chris Walker asked about offering the income tax courses in spring. Will these be offered as hybrid because students need to come to the campus for the weekend events? Vincent Li replied that the VITA programs might not run in the spring. They are working with IRS and IRS is grappling with privacy and security issues. With doing VITA online, there are issues about preparers we do not know having access to sensitive data. Ideally, VITA should be taught on campus; the community wants live VITA. The Chair asked Vincent to keep us posted on the IRS issue.

Jeremy asked if post-Covid, the course could be taught in hybrid mode. He is thinking ahead to a scenario where we might slowly or partially return to campus and hybrid would be doable. David Laderman pointed out that if the district goes into a partial return mode, having hybrid as an option won't mean that classes will be taught in hybrid mode. Mike Holtzclaw, Vice President of Instruction announced that it is highly unlikely that the district will do a partial return. Holding classes on campus will be evaluated on a course to course basis. It would be great if all three options are available but he agreed that having hybrid as an option doesn't mean we will teach a course as hybrid. Lale Yurtseven added that it may mean extra work to complete the sections for all the different teaching modes but she thinks it's worth the effort. We could avoid going through this process for every course. It would be better to just check the box.

Rosemary Nurre and Vincent Li agree that there is nothing wrong with adding hybrid. The Accounting faculty were given the option to have the ACTG courses approved as is, with the addition of hybrid in future proposals, or have proposals returned to them. Finally, the faculty decided to add hybrid to applicable ACTG courses. The courses were returned to them, and they did a quick turnaround and resubmitted the courses for approval.

ASTR 125 Stars, Galaxies, and Cosmology (3) – approved with changes to third party language and online discussion board language. Motion by Martin Bednarek, seconded by Chris Walker, all members voting "Aye".
 (New DE supplement)

Lee had comments on methods of evaluation; she has a list of methods to choose from. Darryl Stanford said he uses the same evaluation methods for face-to-face and online classes. He agreed to add language on discussion boards and change proprietary language per Lee's comments. Lee asked if data is stored in third party platforms and asked about the use of iClickers. Darryl replied that he had used iClickers for in-person courses. Now that classes are online, he still uses iClickers to pose questions to students and get responses, then the class has a discussion and material is clarified. There is good interaction and the students like using iClickers. The use of iClickers reinforces information. Responses are anonymous. For third party software, in Pearson for example, students see their own assignments and grades but not that of others. Canvas is integrated with inclusive access with Pearson. The Chair reminded everyone that college staff need access to documents for audit and accreditation purposes. Lee put language in chat that can be used. The same changes will apply to other ASTR courses.

Chris Smith had a question about hybrid as an option. Chemistry faculty would prefer to have fully online or fully in person. They had some experience with hybrid CHEM classes but these were not very successful. They have been able to make online classes work so far. Jeff Flowers noted that some schools built their programs from the ground up to run as online courses but we have had to make do and make it work.

Ron Andrade had a question about the statement that resources are inadequate. Teresa said that this can be addressed when the course undergoes it's 6-year cycle. SI needs to be added to the list. All accessibility checkboxes were checked.

CHEM 220 General Chemistry II (5) - *approved with changes.* Motion by Martin Bednarek, seconded by Chris Walker, all members voting "Aye".

(New DE supplement; 6-year update) There was a question on how to assess if students complete their assignments. Jeff replied that lab managers put videos together. Students have lab kits and do dry labs and simulations. He agreed to add: Experiments can be assessed using instruments such as rubrics or instructor comments.

COOP 670 Cooperative Education/Work Experience (1-4) – *approved with changes in proprietary language and checked all accessibility boxes.* Motion by Chris Walker, seconded by Martin Bednarek, all members voting Aye".

LaShonda Kennedy pointed out that they do not have a published textbook.

COSM 712 Fundamental Cosmetology I (10) – *approved.* Motion by Chris Walker, seconded by Martin Bednarek, all members voting "Aye". (New DE supplement)

> Jeremy had some concerns about some CTE courses being taught in fully online mode. Post-Covid, we may be affected by funding when taxpayers realize that colleges were able to save funds that would normally go to expenses like facilities and supplies. They might want to continue keeping costs down. The Chair pointed out that some CTE programs require board certification and they require hands-on components. Andria Nalls explained that they have been trying to make online classes work and they face the same issues with faceto-face instruction. Heidi Diamond, Dean of Business and Technology, added that faculty have been going above and beyond normal services in order to make online classes work. Equipment and supplies are still needed. Kits are provided to students. Ideally, programs like Cosmetology will be able to go back to normal. Aurora Medrano added that the State Board allowed CSM to go online for now but this is temporary; they could pull out this permission at any time.

The data should be in Canvas for people to review. She cautioned that anything that captures personal student information including grades should be in Canvas. Chris Walker replied that some third party platforms have capabilities that Canvas doesn't have. Students' assignments are done in third party platforms, then grades are transferred to</li> </ul>

backup documents for the grades, e.g., assignments. He is asking the bookstore to look into how the data in third party software can be viewed by other people like reviewers or accreditors.

The Chair clarified that there are two different pieces to this discussion: FERPA or privacy issues, and evaluation which is an accreditation issue. FERPA is not so much concerned with quality of education, only with privacy, but accreditors look for substantive matters. We can make this work if we have a statement that the grades are in Canvas and the district approved LMS grade book. Having the Third Party checkbox checked raises flags. Chris pointed out that this section in the DE supplement doesn't ask for more specific information, e.g., about the transfer of grades, that's why people haven't been putting in details. He suggested that we provide clearer guidance in the future to streamline the review process, e.g., if more specific details are needed for a certain question or section. The Math Department will submit a memo and the language from the memo will be added to MATH courses after review.
