CIS	124	<ul> <li>Foundations of Data Science (4.0) – <i>approved with minor changes to SLOs. Motion by Chris, seconded by Lale, all members voting "Aye."</i></li> <li>(DE update; 2-year update; change in prerequisites, recommended prep, description, assignments, and texts; proposed for GE Area C1:</li> <li>Math/Quantitative Reasoning Basic Competency) – <i>GE area approved.</i></li> <li>Clarification of the Jupyter Notebook by faculty Hellen Pacheco. Students have access to Jupyter Hub, which is a portal where they log in and do not need any software to install on their computer. Discussion to remove SLO D and F as they are repeated in the SIOs, so SLO D and F will be removed. This course meets GE requirements as it introduces students to basic stats concepts like BUS. 123 and PSYC 121, so the faculty member updated this course with GE requirements. CIS is now wanting to use their own course, CIS 124, as an option to select from their required core courses for their Data Science program. CSM approved math competency here, now the course needs to be taken to Skyline and Canada for</li> </ul>

		verbatim. They were copied into both the SLO and SIO sections to ensure they met this requirement of having them listed on the course outline to

get the class for Area F. This class has never been submitted for Area F. The texts are for 2024 titles which the contributing faculty member was looking ahead to put the proper texts in preparation for the Fall 2024 catalog.

### **OPEN AGENDA**

• Approve Defense Language Proficiency Test (DLPT) SMCCD Policy – Marianne Beck Teresa Morris – approved. Motion by Tamara, seconded by Judith, 10 members voting "Aye", 0 "Nay", and 1 Abstention (Chris Smith).

Jeramy showed the slides from the previous meeting. Chris asked if the test was just listening and if the test expired. Teresa (presenting in place of Marianne Beck) said there is reading and listening, and CSU accepts either if you received the score equivalent to 3 units. There is no expiration date, and Lale compared it to having taken Spanish in high school, then you get credit for having taken it, as the credits are for GEs, not for someone who is majoring in the language.

Teresa pointed out that CSU accepts this for their transfer students, and SMCCD wants to do the same with our local GE general humanities area. This is not proposed for a language course to course; that will be considered in two years, where subject matter experts in the disciplines would

decide equivalency course to course. Approving this policy would help students get on with their educational paths and would positively help those with GI Bills, too.

Committee asked about impact of Cal-GETC on this in 2025, and if it will be accepted. Teresa said that the community colleges can't certify for the UCs, but the UC can determine DLPT proficiency for their students.

This is not only a military test; even non-military can take it and get credit for it if meeting the ACE recommendation score of 1, which is equivalent to 3 units. SMCCD policy proposal is to do the same. CSU doesn't do partial credit to fulfill, so neither will SMCCD – it is 3 units or none for GE Humanities to be satisfied.

## • AB928 and AB1111 Update

Jeramy presented a spreadsheet created by the District Curriculum Chair on all the courses in the District and their current state of alignment. The District needs to get working on getting everything on that document aligned. The CC chairs are reaching out to all departments, and some work was accomplished at last spring's Flex Day. Jeramy is going to work on the backend to get Deans and the VPI involved to complete all the requirements of AB1111. Jeramy asked division reps to go back to their division meetings and tell their colleagues that this is coming down the pipeline.

AB928: There are new Title V regulations around General Education in Section 55060, in which the Chancellor's office has aligned general education requirements to Cal-GETC, so CSM needs to redo its local GE pattern to align with the CSU GE pattern, which will require us to go back and reaffirm everything. This needs to be ready for the 2025-2026 Catalog.
