Chair, Jeramy Wallace, called the meeting to order at 2:19 p.m. Motion by Lale Yurtseven to approve the agenda, seconded by Marsha Ramezane, all members voting "Aye."

Public Comments (2 minutes/person)

Jeramy: We have to wait until the board first approves the actual deactivation of the program to vote on the electronics courses. The board is going be looking at that memo that was sent to us by the PIV Committee. And then after that, we, as a committee, will deactivate the courses.

Beth LaRochelle: At Academic Senate, there was a discussion of pausing Fire for the semester because of budget and concern that the process for PIV wasn't taking place to deactivate. In the evening, the Fire Coordinator was notified by the President that they would commit to keep it open.

Jeramy: There are budget concerns over Fire; they are overbudget. That's a PIV issue, right? If it's not viable, then Academic Senate needs to look at it as a committee. With that being said, we may or may not see a Fire PIV come through the Curriculum Committee. If the budget isn't increased, we would have to look at that. Right now, there is a commitment to not pause it, but what about long term.

Robbie Baden: Curious, so now, of if this happens again, it could be paused?

Jeramy: That's what Todd was arguing that you can't just arbitrarily pause a program. You'd have to go through the process that we've already established. They will figure it out and this issue could come to Curriculum Committee at some point.

Malathi lyengar: Is it an automatic thing that something over budget gets paused? Or does it come from a certain office or body? How does this work?

Jeramy: I think anybody can proposed a PIV to Academic Senate.

Carla Grandy: We are not pausing a program. We are not offering two courses next semester because the program is really expensive, and the budget currently allocated to it is not enough to cover it by close to a half a million dollars. Where does the money come from? We are going to move forward with the offering courses in spring, but again, it wasn't an issue of pausing the program. It was really a scheduling issue. But I do agree with Jeramy's statement that we need to look at it in general and try to understand it better. What resources do we have? This is a program different than most other programs on campus, and it requires a lot of resources, outside equipment, and personnel to be able to run it, and it is also very important to the region. So there's a lot of conversations going on right now. No, it is not an automatic process. It's a decision made at the President-level, and that's what happened with this case. But we'll continue to look at it, and maybe we will be having this conversation more in curriculum. I'm happy to answer any questions if you have one.

Chris Smith: From the perspective of new curriculum coming in, the ability to support a program is one of the things that we are supposed to be considering: if there is a budget or if there are facilities.

Jeramy: Tamara and I met with the District Curriculum Committee to talk about AB1111 and AB928, and this will be agendized for the next meeting.
