#### **Public Comments (2 minutes/person)**

**Jeramy:** Todd was referencing an item that came up in District Curriculum Committee (DCC) regarding a new process to determine equivalency if there is a new AP Exam or other new external exam created or modified significantly. The District now has a process where we bring together the discipline faculty,

articulation officer, and Dean from across the District into a working group (similar to the Equivalency Committee), and they are charged with figuring out equivalency between this exam and the courses that we offer. On the transcript side, the equivalent course would be noted with a code, and the students get credit for the course, and they don't have to retake it. DCC wants the Curriculum Chairs to find the faculty, but we are saying that's more like the Academic Senate's job, so we are figuring that piece out. Be on the lookout related to emails about this. Also, Madeline Wiest mentioned in the chat that they are kicking off the annual external exam review process in the Spring, and it would be a great time to revisit discipline equivalencies. ART	234	Introduction to Printmaking (3.0) – <b>postponed.</b> Suggestion to change title to "Printmaking I" to align with Skyline's ART 234 and need Discipline Assignment.
BIOL	221	Botany (4.0) – <b>approved.</b> Discipline assignment: Biology. Motion by Shana Young, seconded by Chris Smith, all members voting "Aye." (New DE Supplement; proposed for GE Area E5; existing course modification with new course number) Units changed from 5 to 4 so that the course matches up for transfer. Chris is working with Marsha on the Biology AS-T Degree alignment.
ESL	835	ESL for Parents of Elementary School Children (2.0) - <b>approved with changes to</b> <b>description, credit notation, and SLOs.</b> Discipline Assignment: ESL. Motion by Dave Laderman, seconded by Tamara Perkins, all members voting "Aye." Discussion among the Committee related to "non-credit" designation and issues with District ITS and the backend work to get this type of notation on the schedule. Faculty agreed with suggestion to change this to a "credit" course, so it will be 2-units, non-degree applicable.
матн	221	Preparation for (B)STEM Math (4.0) – <i>approved with inclusion into GE Area 2, changes to description and SLO</i> . <i>Discipline assignment: Mathematics. Motion by Chris, seconded by Malathi Iyengar, all members voting "Aye."</i> (New DE Supplement) Faculty will work with Jeramy on SLO and description change. Committee suggested to add this course to CSM Local GE Area 2, and faculty agreed.

## • Course Modification(s)

COSM 763 Braiding and Hair Design I (1.5) – approved. Motion by Lale, seconded by Sujata Verma, all members voting "Aye." (DE update; 2-year update; change in prerequisite)

# • New Program(s)

- Modern Policing AS Degree (45 units) *approved with edit on List B unit count total*. Motion by Marsha Ramezane, seconded by Leo Cruz, all members voting "Aye."
  List B units should total 30-33, which then changes the total for the degree to 42-45 units.
- Sales Professional Certificate of Specialization (15 units) *approved*. Motion by Lale, seconded by Chris, all members voting "Aye."

#### • **Program Modification(s)**

- Broadcast and Electronic Media AA Degree (Addition of 1 required course, total units increased from 18-21)- *postponed.*
- International Business Certificate of Achievement (modification of required and non-core course units) *approved*. *Motion by Chris, seconded by Sujata, all members voting "Aye."* Faculty created this certificate to provide more stackable certificates that are lined up with the AS and Transfer Degree, so students don't have to take extra courses.

## **OPEN AGENDA**

• **Curriculum Handbook – approved.** Motion by Malathi, seconded by Tamara, all members voting "Aye."

Members have had two months to look at a draft and opportunities to give feedback, comments, revisions, edits, and deletions. Committee discussed section on TBA, and Chris Smith is going to locate a document from the State Chancellor's Office for guidance on the description for TBA. Guillermo Cockrum, CSM SLOAC, commented on best practices and a shared commitment for SLOs to align with program learning outcomes and ultimately with Institutional Learning Outcomes (ILOs). Committee approved these edits, and Jeramy will compile and post. Next semester, the Committee will work on the GE Handbook, and Jeramy asked for volunteers to work on that.

## Area 7 Courses

Committee discussed the inclusion of COMM 110, 115, 130, 140, and 150 in Area 7. Kristi Ridgway shared documentation from the COMM faculty justifying these courses as they align with Self-Development Outcomes. Another aspect of this is that Cal-GETC is not yet clear regarding which section COMM courses will fit into, so that's an additional item to consider as to what courses students will take. In discussing the merits of including certain COMM courses into Area 7 based on interdisciplinary reasoning or applicable skills, Chris Walker, former CC Chair, stated that when he was working on this Area, the focus for these types of courses was: does your course do these things as a whole; is the purpose of the course for self-development? Committee noted that some of the course outlines do not match with the justifications that Kristi shared.

COMM C1000 (formerly COMM 110): Public Speaking (3) – *denied*. 4 "Ayes," 6 "Nays" (Dave Laderman, Chris Smith, Malathi Iyengar, Beth LaRochelle, Wai Yan Oo, Lale Yurtseven), 0 Abstentions.

COMM 115: Survey of Human Communication (3) – *denied*. 1 "Aye," 9 "Nays" (Leo Cruz, Dave Laderman, Trang Luong, Chris Smith, Beth LaRochelle, Sujata Verma, Wai Yan Oo, Malahti Iyengar, Lale Yurtseven), 0 Abstentions.

COMM 130: Interpersonal Communication (3) – *approved.* 6 "Ayes," 2 "Nays" (Chris Smith, Malathi Iyengar), 2 Abstentions (Dave Laderman, Wai Yan Oo).

COMM 140: Small Group Communications (3) – *approved*. 3 "Ayes," 2 Nays" (Chris Smith, Malathi Iyengar), 4 Abstentions (Wai Yan Oo, Dave Laderman, Beth LaRochelle, Leo Cruz).

COMM 150: Intercultural Communications (3) – **approved**. 3 "Ayes," 5 "Nays" (Beth LaRochelle, Dave Laderman, Chris Smith, Wai Yan Oo, Malathi Iyengar), and 1 Abstention (Leo Cruz). Continued discussion related to Chris Walker's point of whether or not this course as a whole and its purpose is for self-development. Additionally, further comments by the Committee about how the course outlines says one thing, but there's an informal explanation that the course will do something totally different, and that makes it difficult for instructors, especially new ones, to teach these courses.

PSYC 310: Positive Psychology (3) – *denied*. 3 "Ayes,"4 "Nays" (Beth LaRochelle, Dave Laderman, Chris Smith, Malathi Iyengar), and 2 Abstentions (Leo Cruz, Wai Yan Oo). Psychology faculty felt like this course meets the requirement of Area7b5: Implement personal development strategies for maintaining financial, physical or mental well-being. Committee discussed how course focuses more on theory vs. practicality. Judith Hunt said that if Psychology faculty care enough about having this course in Area 7, they will revise the course outline to make it representative.

PSYC 320: Psychology of Wellness: The Mind-Body Connection (3) – *approved.* 8 "Ayes," 1 "Nay" (Chris Smith), and 0 Abstentions.

The content sounds academic, but the course description sounds like students will be doing the techniques.

PSYC 330: Sports Psychology (3) – *denied*. 0 "Ayes," 9 "Nays" (Beth LaRochelle, Leo Cruz, David Laderman, Trang Luong, Chris Smith, Wai Yan Oo, Malathi Iyengar, Lale Yurtseven, Sujata Verma), 0 Abstentions.

Any student can take this course, but description reads very theoretical.

Kinesiology emailed Jeramy and requested to take DANC 400 out of Area 7.

## • Course Placement for Area 2: Mathematical Concepts and Quantitative Reasoning – postponed.

CSM's old local degree included a math competency, but no general education area specifically for math courses. Math was thrown into one area that included oral communications, critical thinking, and analytical thinking. Now we have to go through and separate out the math courses since it has its own area now. For our meeting in January, we will have the conversation of which of the classes in our current Area 1B should be moved to the new Area 2. Apologies to Chris Walker, Dean of Math Sciences, for joining the meeting, but we didn't get to the actual selection today.

## • Ethnic Studies and AH & I

Malathi reported back that the Ethnic Studies department agreed to take out the ethnic studies courses from Area 8: American History and Institutions.
