BIOL 110 General Principles of Biology (4.0) – approved with changes to recommended prep and DE supplement. Motion by Jeremy, seconded by Marsha Ramezane, all members voting "Aye."

GBST 102 Global Issues (3.0) – *approved.* Motion by Lale, seconded by Chris Smith, all members voting "Aye."

(New DE supplement; 6-year update; change in title, recommended prep, description, assignment, and texts).

GBST 101 and GBST 102 discipline assignment of History OR Economics OR Political Science OR Business OR Philosophy OR Geography OR Anthropology OR Sociology OR Social Sciences – **approved**. Motion by Lale, seconded by Marsha, all members voting "Aye."

Title change to match with C-ID descriptor change and alignment with other college.

# PHIL 103 Critical Thinking and Argumentative Writing (3.0) – *postponed*.

(DE update; 6-year update; change in title, prerequisite, recommended prep, description, SLOs, objectives, content, instruction, assignments, evaluation, and texts.)

Discussion on the premise for the changes made to this course that is a 103 course, which is traditionally considered a critical thinking course number, so there is critical thinking and an added writing component to the outline. Members commented that with the writing added to the course and in the title, the course "feels very new, and the SLOs reflect that as well."

Members and faculty author agreed that Course Content Part 4 could be expanded and be more robust to include more about the writing process and integrate the reading and writing aspect. Idea of a small workgroup to meet in collaboration with Philosophy. Jeremy will take the course back and work with Jeramy. PHIL 210 will go through a similar treatment. Plan to get PHIL 103 on the final CC agenda so that Marsha can submit for UC transferability.

### **OPEN AGENDA**

## Area 7

Jeramy presented on the current status of Area 7. The District Curriculum Committee (DCC) met on Monday and took a vote on what the DCC recommends for GE Area 7: Self Development and Wellness, 3 units, with a minimum of 1 unit from 7A. Only classes not listed in other areas will qualify for Area 7. Jeramy shared the DCC recommendation on screen, and a copy will be sent out to the CC members. The general consensus was that this was a good compromise.

Lia, Judith, Jeramy, and Todd worked on the rubric for Area 7's description. The members reviewed and discussed how courses could be developed and/or if they fit into the rubric. Lengthy discussion on "creative expression" and whether or not to include this in Area 7. It was pointed out that students can select creative expression courses as their electives, so they have that option if it is not included in Area 7. This updated rubric document will also be sent to the CC members.

Next steps: DCC document and rubric document will be sent out to members for review and to also bring to the Divisions for feedback. CC will vote on both items at the May 9<sup>th</sup> meeting. Then documents will go to Academic Senate on May 17<sup>th</sup>, and then back to the DCC on May 20<sup>th</sup>, where all three campuses come together to see if there's support for this and make adjustments if needed.
