Nursing Department Prerequisite Evaluation Form

The CSM Nursing Program has a number of prerequisite courses that students MUST complete prior to applying to the program. These prerequisite courses are listed on the Nursing Program website. Some students may have completed courses outside of the San Mateo County Community College District (College of San Mateo, Cañada College, and Skyline College) and wish to have the courses reviewed so that the course may be approved to meet the CSM course prerequisite.

In this regard, please use this information sheet.

- 1. The SMCCCD prerequisite courses for the CSM Nursing Program are listed on the CSM Nursing website.
- 2. The CSM Nursing Program website includes a Nursing Articulation <u>https://collegeofsanmateo.edu/nursing/docs/CCCNURSINGGRID2023.pdf</u> that lists courses taken outside of SMCCCD that meet the program prerequisites. If you have completed a prerequisite course outside of SMCCCD first use the Nursing Articulation Grid. If you find the course you have completed on the grid then the course is already approved to meet a CSM Nursing Program prerequisite. If a course you completed does not appear on the grid, review number 3 below.
- 3. If you do not attend a college in SMCCCD (College of San Mateo, Cañada College, Skyline College) you will need to use the PRE-ADMISSION NURSING PROGRAM PREREQUISITE EVALUATION form (the next page). The deadline for submitting this form is listed on the CSM Nursing Program website.
- 4. Other Nursing Program Prerequisite information:
 - a. A student may not repeat a program prerequisite course in which a grade of "C" or higher was earned for the purpose of CSM Nursing Program admission (within the recency requirements).
 - b. No more than 2 attempts total are permitted for the Biology courses (Microbiology, Anatomy & Physiology or equivalents) within the 5-year recency requirement.
 - c. If a student has repeated Microbiology, Anatomy & Physiology (or the equivalents) within the 5-year recency, 2 points are deducted from the application for *each* repeated course (reference: <u>Merit-Based Criteria</u>).
- 5. Submit the course description(s), official transcript(s) and the prerequisite evaluation form to Marsha Ramezane ramezane@smccd.edu. CSM Nursing department will not accept any copies.
