San Mateo County Health is now holding mass vaccination clinics for ALL COVID-19 booster vaccinations at the San Mateo County Event Center - Moderna, Pfizer and J&J all available!

Appointments STRONGLY encouraged. If possible, please bring an ID and your vaccination card.

If you are eligible (click <u>HERE</u> for eligibility information) and interested in receiving a booster at the Event Center, please go to <u>MyTurn</u> and search for the Event Center address: 1346 Saratoga Drive, San Mateo (see directions below, or on the SMC Health Facebook page).

Vaccine Used: Pfizer, Moderna, and Johnson & Johnson (aka Janssen)

Location: San Mateo Event Center: 1346 Saratoga Dr, San Mateo, CA 94403 [Click <u>HERE</u> for map]

Dates and Time:

- Tuesdays from 12 7 pm
- Wednesdays/Thursdays/Fridays/Saturdays from 9 am 4 pm

Details:

- This is a Drive Through Vaccine Clinic
- Appointments are strongly encouraged, though registration can be done on site
- If possible, please bring a form of identification with your name on it. Examples include a driver's license, work ID, library card, letter from your employer or school, bank/ATM cards, electrical bill, matricula consular, paystub, passport, money transfer receipt, etc. Please note that the document does not need to be a government-issued ID to receive a vaccine.
- · Wear clothes with sleeves that can be rolled up
- You will need to wait a minimum of 15 mins for observation after vaccination before leaving
- This clinic is for booster doses, though first and second doses are also available

In preparation for the Spring 2022 semester, Cañada College, College of San Mateo and Skyline College are requiring all students to be vaccinated in order to take in-person courses, and receive in-person services (Admissions and Records, Counseling, Library, Tutoring, etc.). If you wish to take in-person classes and receive in-person services, you must provide proof of vaccination or your documented reason for an exemption. If you do not provide proof of vaccination or if you are not approved for an exemption, you may only take online courses and receive virtual and remote support services.

Starting this week, you will be asked to upload your COVID-19 Vaccination information in WebSMART. Again, this is in preparation for the Spring 2022 term, and will not impact your classes and services this Fall 2021. You will receive instructions for uploading vaccination information this week.

The Jack Kent Cooke Undergraduate Transfer Scholarship is now open on Common App for Transfer.

The deadline date to apply is January 10, 2022.

Eligibility Requirements:

- Sophomore Status Be a current student at the College of San Mateo and plan to enroll full-time in a baccalaureate degree program at an accredited college or university in the Fall 2022.
- Have a cumulative grade point average of 3.50 or better.
- Demonstrate unmet financial need. They will consider applicants with family income up to \$95,000.
- No previous enrollment or attendance at a four- year institution.
- The scholarship will provide up to \$55,000 per year to attend a four-year accredited undergraduate college or university.

Help to keep our college community healthy and safe:


- Monitor daily for signs of illness. Stay home if sick and report to appropriate instructor or college staff

- Sanitize hands and works spaces frequently to reduce the spread of germs


Ask the Doctor: COVID-19 Boosters

This ongoing feature addresses common student health questions, answered by CSM College Physician Dr. Jennifer Yang.

Dear Doc: Can you tell me more about the "mixing and matching" approach when choosing a Covid-19 booster shot? Is it better than getting the same type of vaccine I initially got? Should I wait until more studies are done? -Boost Me or Boost Me Not

Dear Boost Me: Thanks for reaching out. I'm glad to hear that you are thinking about getting your booster vaccine. From a physiologic standpoint, the more foreign elements your immune system is exposed to, the better prepared it will be to fight off infections. I like to use an MMA (mixed martial arts) analogy: If you happen to find yourself in the middle of a street fight, with no knowledge of what skills your opponent (a.k.a. Covid-19 variant) has, would you be better off knowing a bit of jujitsu, karate, and boxing, or do you think you'd fare better being a third- degree black belt in karate?





What is the risk you take if you wait to get your booster shot? Well, we are heading into the holidays and for most of us that means hanging out indoors with family and friends. Many of us will be traveling. There was a huge spike in infections last year coming out of the holidays. For these reasons, I would not wait to get my booster. Nothing is a 100% guarantee, but if I can reduce the chance that I will get and or spread Covid-19, I am going to make sure I protect myself, my family and my friends.

- The Fall 2022 application filing period for UCs is November 1, 2021 November 30, 2021.





California's Eviction Protections Changed October 1: Renters and Landlords Impacted by COVID-19 Should Still Apply for Rent Relief

Are you at risk of eviction?

Eligible applicants who have applied to the program cannot be evicted.

You have 15 days to tell your landlord you are applying for rent relief.

The CA COVID-19 Rent Relief program covers 100% of unpaid rent and utilities for eligible renters and their landlords who have been impacted by COVID-19. The program will continue accepting applications until all funds are exhausted. Beginning October 1, 2021, state eviction protections changed, and a renter should apply to the program if they haven't already, to prevent eviction.

As of October 1, 2021, landlords seeking an eviction based on non-payment of COVID-related debt or of rental debt incurred between October 1, 2021 and March 30, 2022, must prove that that they have applied to the COVID-19 Rent Relief program, and that the application has been denied or the renter has failed to complete their section, before a legal eviction can take place. Eligible renters who are at risk of eviction are urged to apply, even if their landlord has not applied.
