

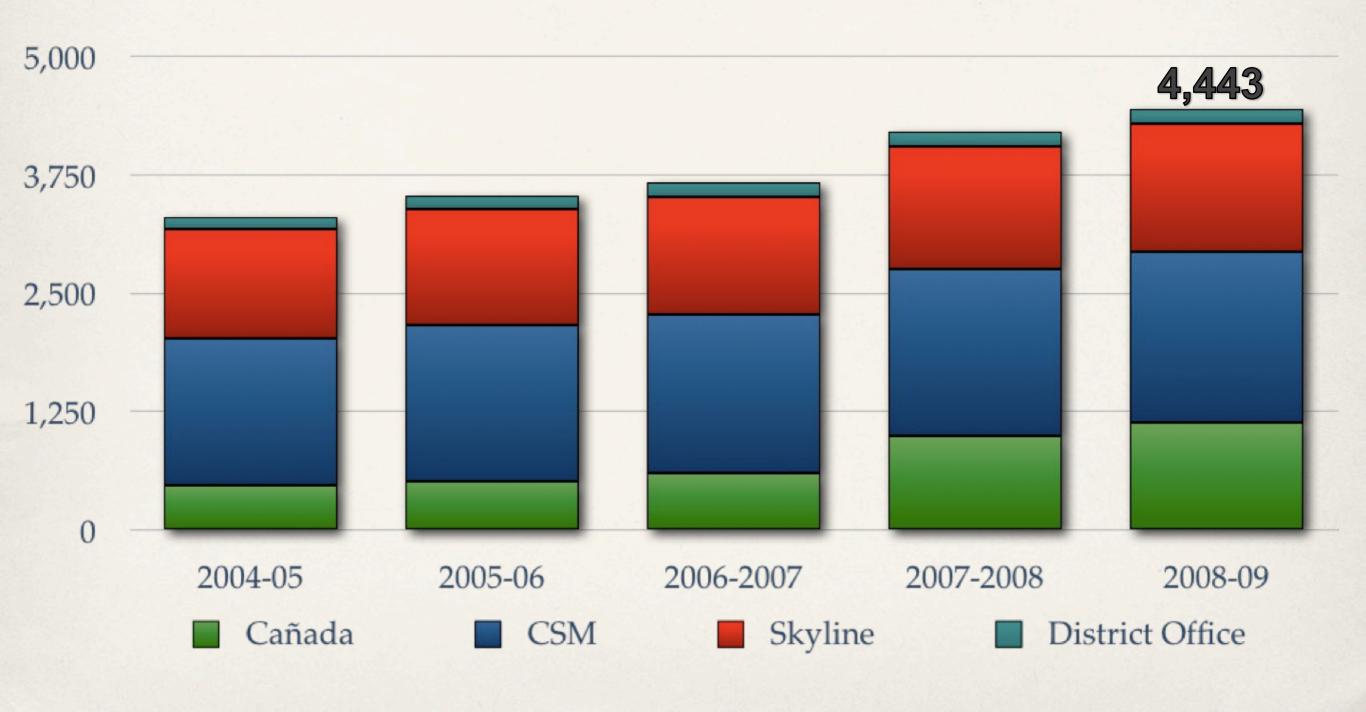

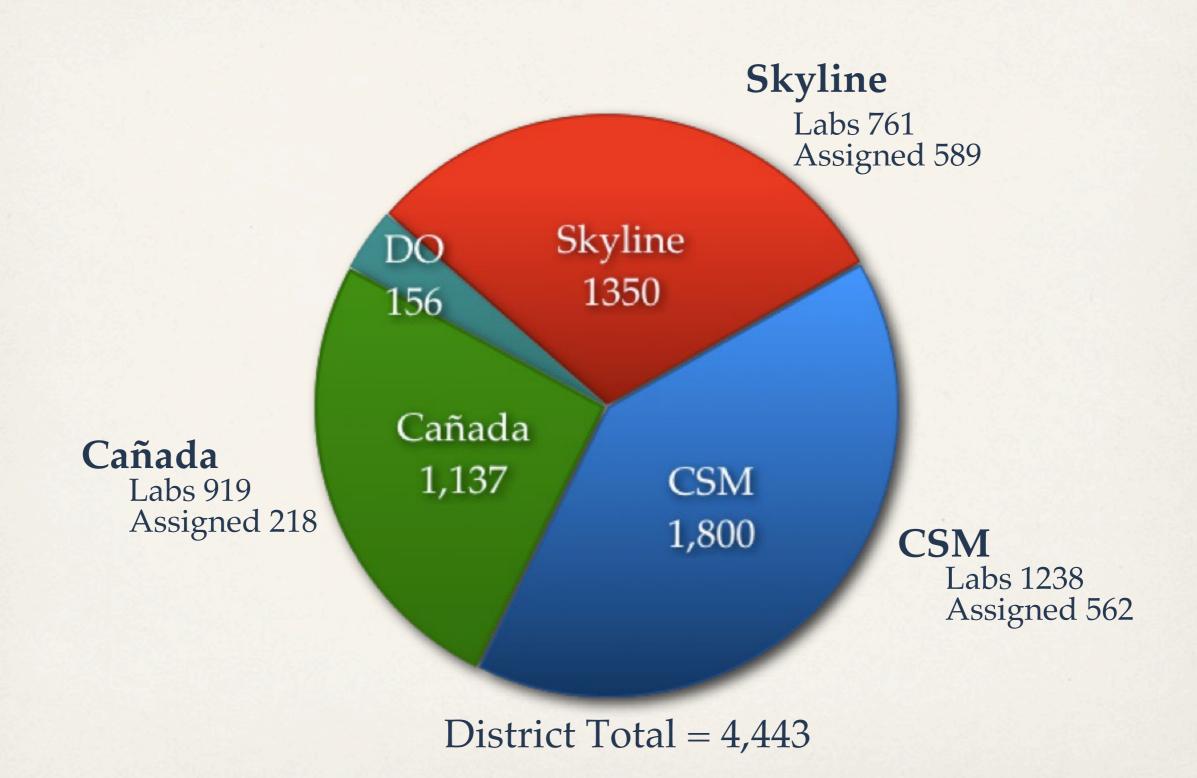

Growth of Computers by College

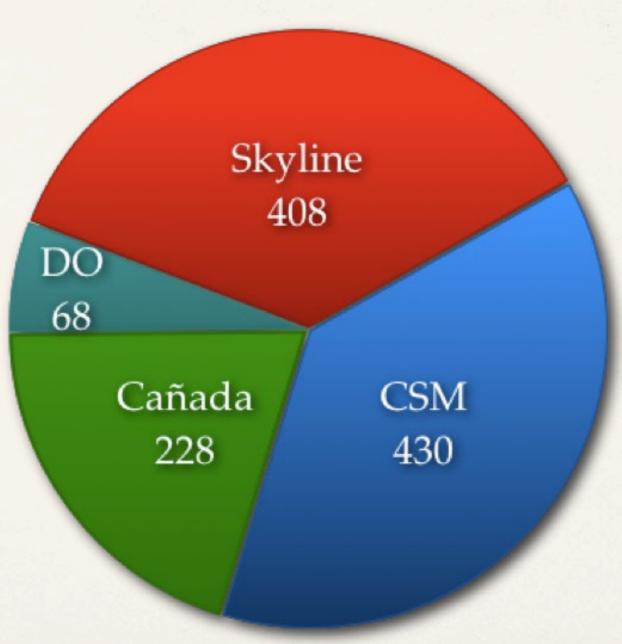


Computer Distribution - Feb. 2009



Printer Distribution - Feb. 2009

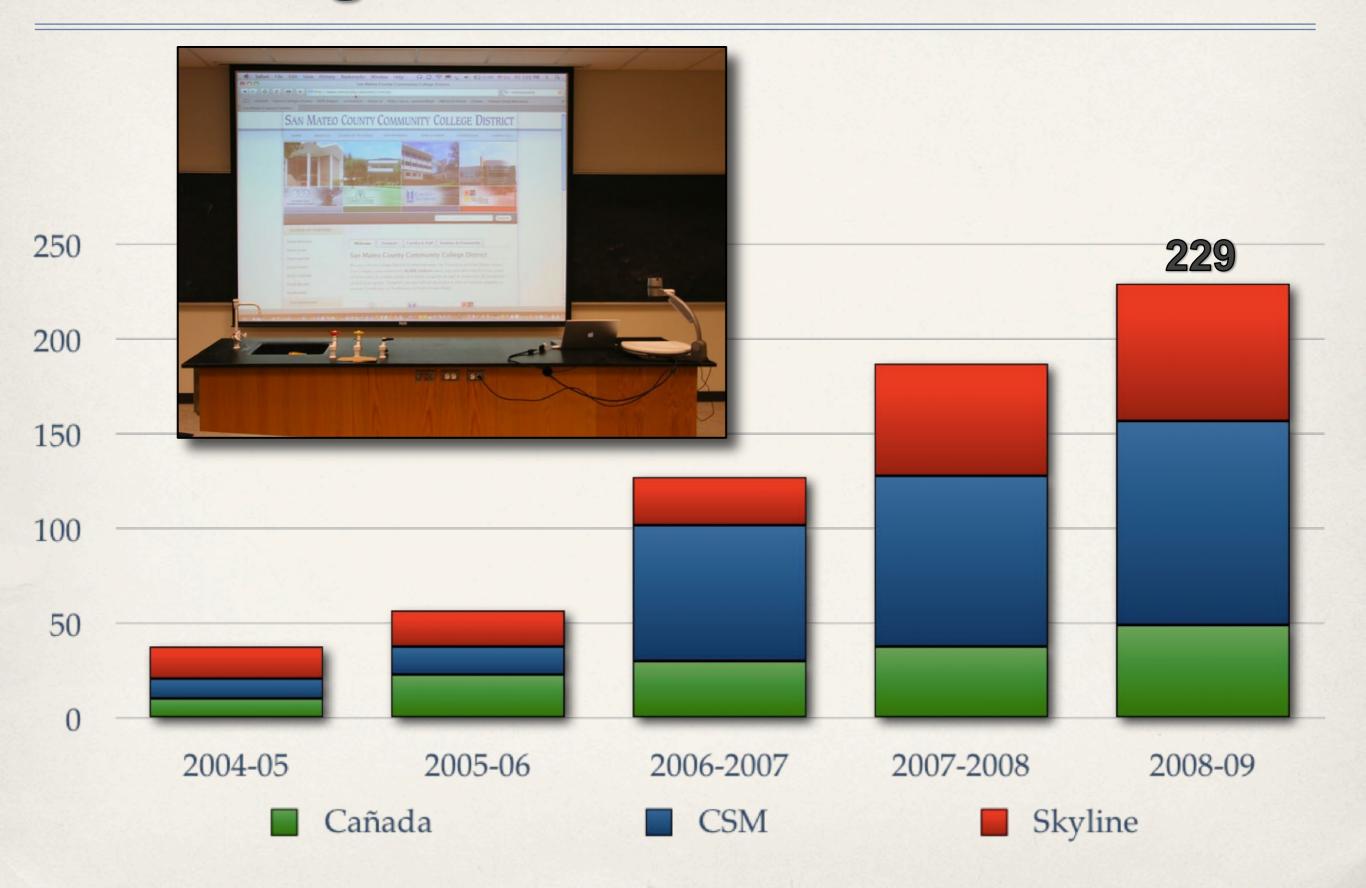




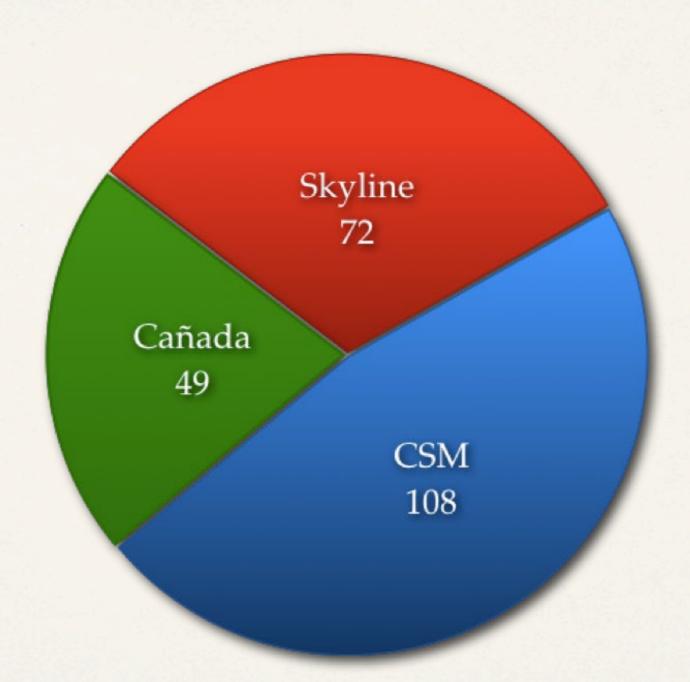

Increasing Smart Classrooms



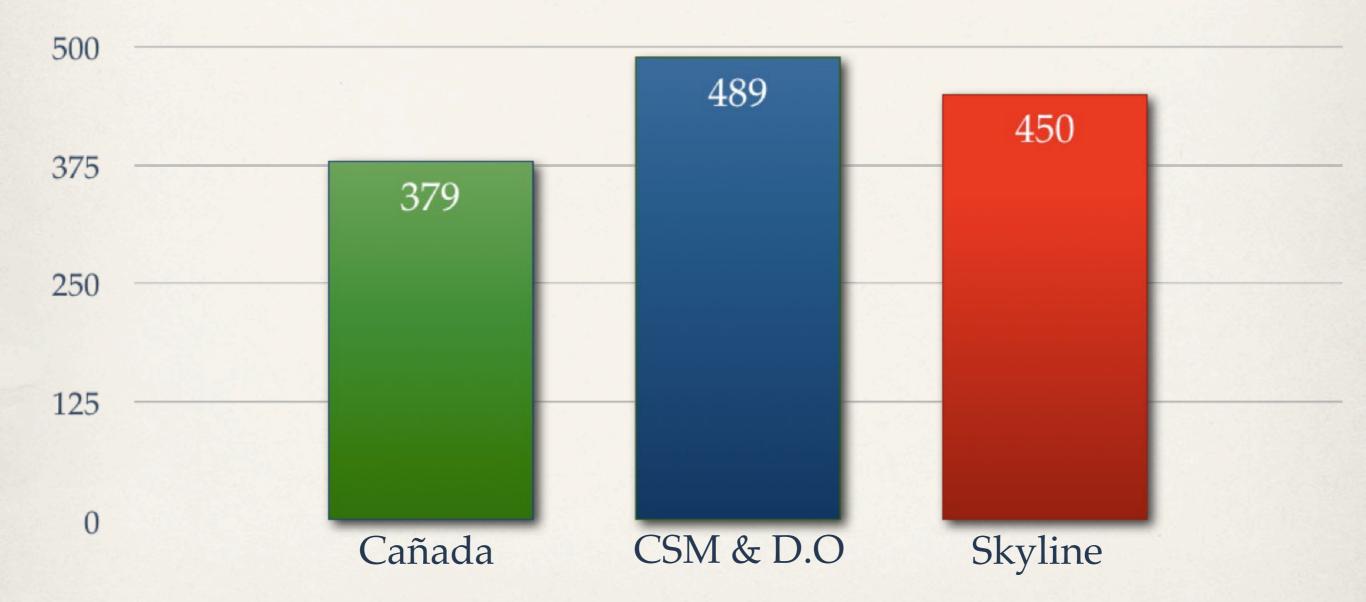
Smart Classroom Distribution
